Application for DMMO under Section 53(5) of the Wildlife and Countryside Act 1981 _Bridleway 17 Beaminster, Bridleway 35 Beaminster - T354

I object to this application mainly on a short point. Although dated 21 Dec 2004, the application was not in fact lodged with DCC until 6 Feb 2005. It was thus after the cut-off date on 20 Jan 2005 and does not benefit by way of 67(3). from exemption from the provisions of s67(1) NERCA. That precludes mpv rights ie BOAT status.

As a secondary point, the applicant said this:

FoDRoW believes enough evidence is being submitted to justify this -claim. Further evidence does exist and may be submitted at a later date, However, having considered the volume ofclaims likely to be submitted in the coming years this claim is being submitted now to avoid a future flood of claims when they are allfully researched

Ihat too results in the application failing to qualify. As expressed by George Laurence QC in a joint opinion with Ross Crail in Jan 2007:

14 (1) The criterion for inclusion of documents in the list and set of copies to accompany the application is that they be 'any documentary evidence (including statements ofwitnesses) which the applicant wishes to adduce in support of the application ". The time at which the applicant 's wish to adduce a particular documentfalls to be tested is at latest the date when he submits his list and set ofcopies and perfects his application.

and

(4) However, "any documentary evidence " must in the context ofparagraph 1 be read as equivalent to "all documentary evidence"; so if the applicant deliberately keeps some material back when submitting his original batch, or does not defer his application until he has finished researching and collating material, he is not complying with the requirements ofparagraph 1.

Whether the evidence justifies reclassification to RB status is a matter for the Council to decide. [See footnote as to evidence offered.]

The law

NERCA 2006

- 67 Ending of certain existing unrecorded public rights of way
- (l) An existing public right of way for mechanically propelled vehicles is extinguished if it is over a way which, immediately before commencement-

But this is subject to subsections (2) to (8).

- (3) Subsection (1) does not apply to an existing public right of way over a way if -
- (a) before the relevant date [20 Jan 2005], an application was made under section 53(5) of the Wildlife and Counfryside Act 1981 (c. 69) for an order making modifications to the definitive nup and statement so as to show the way as a byway open to all traffc,

SCHEDULE 14 TO THE WILDLIFE AND COUNTRYSIDE ACT 1981 Applications for certain orders under part Ill, Section 53 Form of applications

- 1 An application shall be made in the prescribed form and shall be accompanied by—(a)
- (b) copies of any documentary evidence (including statements of witnesses) which the applicant wishes to adduce in support of the application.

In the Winchester appeal case it was held that the regulations must be strictly applied. Other than as to the scale of maps, that was upheld by the Supreme Court in the Dorset case.
