RW/T533 - Part of Footpath 30, Church Knowle at Charmswell Definitive Map and Statement Modification Order

I write on behalf of the Scott Estate with regards to the above Modification Order 25th October 2019.

The Scott Estate is responsible for the reservoir immediately to the north of the proposed footpath modification and indicated edged in red on the enclosed plan.

This water supply is the only source of clean drinking water to 20 households and serves an area of approximately 2.5km. Mains water is not available.

The proposed modification of footpath 30 alters the route of the footpath so that the proposed new route runs directly between the source of the spring and the Estate's water treatment facility. The existing route of footpath 30 runs above the spring head and consequently above the water treatment facility.


This is a matter of major concern to the Scott Estate for two reasons:-

- 1. The new route will enable public access to the treatment facility (increasing the potential for break-ins and theft).
- 2. It significantly increases the possibility of the water supply being contaminated by dogs and people as they will now be within the immediate proximity of the spring. Creating a liability to the Estate where, with the footpath on its existing route, the risk is minimal.

As a result the Estate wishes to object to this proposed modification.



Wildlife and Countryside Act 1981 Dorset Council (Part of Footpath 30, Church Knowle at Charmswell) Definitive Map and Statement Modification Order 2019 Dated 25th October 2019

We write to advise you that we object to the above order on the following grounds:

- 1) The Council Report considering the evidence, put before the County Council Regulatory Committee on 6 December 2018 at County Hall, Dorchester was biased and did not give a balanced representation of the evidence available at the time.
- 2) The route described in the modification order is not, on the balance of probabilities, the most likely correct route of the way with public rights.

We respectfully request that the Council take notice of this objection and refer the matter to the Secretary of State for the Department of Environment, Food and Rural Affairs for determination as an opposed order.
