Thank you for your emails.

In response to your first email:

I can confirm that Dorset Council has already submitted an objection to the modification to the order.

We have not provided to the Inspector the documents to which he refers in the interim decision as having been relied upon by the Council in their determination, but which did not reach him. The majority of these maps are included on the FODROW CDs, copies of which have been provided to the TRF recently and therefore should be available to you.

With regard to the user evidence forms, you will note from the Council's Committee report that two consultations were undertaken, one in 2009 and one in 2018. The user evidence forms are dated 2008, 2009 and 2010. None of the user evidence forms were provided by the applicant. They were all submitted by individual members of the public and members of the TRF. Most of the forms were received in response to our consultations, however some were received prior to that from people who became aware of the application and wished to provide evidence in support.

In response to your second email:

What was shown on the List of Streets as at 2/5/06 (list not available, map only) and now (list and map) is attached. There are no handover records for this area. Please clarify what you mean by "earlier highway records".
 The List of Streets was held as a list on 2/5/06 with an accompanying map.

3. My colleague is collating the requested documents. They will be forwarded as soon as possible.

4. Please clarify what you mean by "Definitive Map records".

Dorset Council (A Byway Open to All Traffic) Beaminster at Crabb's Barn Lane, Definitive Map and Statement Modification Order 2020

We act on behalf of the Trail Riders Fellowship (TRF) in respect of the above mentioned DMMO submitted to PINS.

Please could you confirm that the Council will be objecting to the modification and pressing the case that all of C-D-E-F-G-H-I is a public vehicular highway.

Please could you also confirm that the Council will be providing to the Inspector the documents to which he refers in the interim decision as having been relied upon by the Council in their determination, but which did not reach the Inspector.

Finally, you may recall that in the Cheselbourne case (Bridleway 8 (part) Cheselbourne and Bridleway 18 Dwelish) you confirmed to our client that the further evidence (the user evidence) came about because the Council solicited it and thus could not be said to be a deficiency as to the original application. The email is attached and the relevant part reads:

"...With regard to the user evidence forms, Dorset County Council (as it was then) undertook a consultation process inviting the public and various interested parties (including the TRF) to submit evidence in January 2006 and also in September 2009. The user evidence forms were submitted to us in Feb/Mar 2010 in response to these consultations and as part of our investigation. They cannot be considered to have been submitted as part of the application by the applicant, as the applicant at that time was still FoDRoW/ Jonathan Stuart. As you know, the TRF did not take over the application until 4 October 2010."

This email was written in the context of Cheselbourne (i.e. another of the Dorset map scale routes), but presumably the same applies to this route. Are you able to please provide a similar confirmation for this route?

We are preparing our representations this week and would be grateful for your prompt response.
