

I am authorised to reply on behalf of the South Dorset Group of the Ramblers. The details have been examined and a site inspection made and I wish to make the following response.

We are not happy to agree to the diversion of Footpath 26, Cheselbourne or the extinguishment of Footpath 16, Melcombe Horsey. The proposed route is substantially less convenient to the public, particularly when walking north – south, as it involves an additional length of tarmac path on Bridleway 19 between points C and D to gain access to the new route of Footpath 26. The proposed extinguishment of Footpath 26 would also remove potential links to Open Access Land.

We were surprised to receive these consultation documents, as the same proposals were opposed by the Ramblers at the Pre-Application stage. A letter was submitted at that time giving our reasons for this response which does not appear to have been taken into consideration.
