

Purbeck Local Plan Examination:

Update on Policy I6 - Wareham integrated health and social care

September 2022

Dorset Council

Health and social care priorities.

- The PCT recently withdrew from the proposal to focus health provision in Wareham at the former middle school site. The GP Partnership still wishes to relocate to the middle school site. The council is proposing to update Policy I6, its supporting text and Proposals Map to reflect this whilst not preventing the delivery of further health services on site in the future.
- 2. The council's Building Better Lives Team have indicated that they will no longer be linking the redevelopment of Anglebury Court in Bonnet's Lane to the development on the middle school site, or on the original timetable and, accordingly, the housing delivery on this site has been moved to the end of the plan period and consequently removed from the 5-year housing supply. These changes are reflected in the housing supply data provided as part of the council's recently published technical paper on nutrient neutrality and housing land supply/delivery (in response to the Inspectors' note 19 August).

Proposed Changes

- 3. In summary the proposed changes are:
 - a. remove Streche Road from I6 on the Proposals Map;
 - b. remove Anglebury Court from the Proposals Map. It can be redeveloped later in the plan period without being identified as part of I6;
 - c. update Policy I6 and its supporting text to reflect the changes whilst not preventing the delivery of further health services on the middle school site in the future.
- 4. These changes would be consulted upon as part of any further consultation arising during or since the recent hearing in July 2022.

 - d. the policy, or supporting text, as it was drafted in the submission draft version of the Purbeck Local Plan [SD1a], or Main Modification version (MMCD1) if appropriate;

 - f. a modified version of the policy, or supporting text, showing the changes from the text, as it was drafted in the submission draft/main modifications version of the local plan. Where the modification is as a result of an additional further modification this is indication by using italics).

Proposed Supplementary Main Modification (SMM01): Chapter 6, Infrastructure, paragraphs 263-267

Submission draft text:

Paragraphs 263-265

264 Dorset County Council's Building the Right Assets - an Adult Social Care Accommodation Needs Assessment 2018-2028 identifies the District's needs for adult social care accommodation; respite accommodation, residential and nursing care and key worker housing. Many of these requirements will be delivered as part of the Community Health Hub in Wareham, an associated care village, or developing additional capacity around existing Council owned sites. Currently Dorset County Council is considering using part of the Middle School site for temporary modular housing which can be moved when the health hub project is advanced further.

265 The NHS locality team is working closely with County Council's Adult Social Care Team to maximise the use of their assets in Wareham to achieve integrated health and social care in Wareham. The key sites are the former Middle School site on Worgret Road and NHS property on Streche Road - hospital, GP surgery and ambulance station.
