

Public Path Diversion and Definitive Map and Statement Modification Order

Highways Act 1980 Wildlife and Countryside Act 1981

Dorset Council (Part of Bridleway 31, Hilton at Manor Farm) Public Path Diversion Order 2021

This Order is made by Dorset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the bridleway described in paragraph 1 of this Order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Dorset definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Mrs Arabella Agar has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the way into a fit condition for use by the public.

Hilton Parish Council has been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1. The public right of way over the land situate at Manor Farm, Hilton and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation of this Order or on the date which Dorset Council certify that work has been carried out to bring the site of the new highway mentioned in Part 2 of the Schedule to this Order into a fit condition for use by the public, whichever is the later and thereupon the County of Dorset definitive map shall be modified by deleting from it that public right of way.
- 2. Notwithstanding this Order, where immediately before the date on which the way is diverted in pursuance of this Order, there is apparatus under, in, on, over, along or across the way belonging to the statutory undertakers for the purpose of carrying out their undertaking then such undertakers shall continue to have the same rights in respect of their apparatus as they would have had if this Order had never been made.
- 3. There shall at the end of 7 days from the date of confirmation of this Order be a public bridleway over the land situate at Manor Farm, Hilton described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order and thereupon the County of Dorset definitive map shall be modified by adding that way to it.
- 4. The County of Dorset definitive statement shall be modified as described in Part 3 of the Schedule to this Order.

SCHEDULE

Part 1

Description of site of existing way

Part of Bridleway 31, Hilton:

E – B – C The full width of the bridleway, from the unaffected part of Bridleway 31, south of Manor Farm House at point E (ST 77970353), north west along a tarmac/stone surfaced driveway to the properties Manor Farm House and Bramleys to point B (ST 77900364), then south west along a grass field edge passing to the north and west of Bramleys to rejoin the unaffected part of Bridleway 31 at point C (ST 77790360). (No recorded width).

Part 2

Description of site of new way

Part of Bridleway 31, Hilton:

E – F – C From the unaffected part of Bridleway 31, at a tarmac/stone surfaced driveway, south of Manor Farm House at point E (ST 77970353), south west into a field and continuing south west along a double fenced grass surfaced path to point F (ST 77850352), then north west along a double fenced grass field edge to rejoin the unaffected part of Bridleway 31 at point C (ST 77790360). Width: The width of this part of Bridleway 31 is 4 metres.

Path No 1 near Manor Farm, generally west and north west to a tarmac/stone surfaced driveway, south of Manor Farm House at ST 77970353, south west into a field and continuing south west along a double fenced grass surfaced path to ST 77850352, then north west along a double fenced grass field edge to ST 77790360. Continue generally west south west and north west to Cuckoo Lane Pond.
