## **Regulation 16 publication of Bere Regis Neighbourhood Plan**

If agreed by the Council and the planning inspector, a referendum will be held followed by the plan being formally adopted and used to determine planning applications in the Neighbourhood planning area.

The statutory six week period for making comments starts on **Monday 15 October and all responses should be received by Monday 26 November 2018**.
