The number of dwellings should be increased from 825 to reflect the higher housing target now being proposed. Many of the same arguments for development at Stalbridge, also apply to the Larger Villages, i.e. maintaining the vitality and viability of these settlements and ensuring their future sustainability, and providing possibilities in terms of improving the existing infrastructure provision in the town. It should not be assumed that development in the Larger Villages would necessarily result in negative impacts on the character and appearance of those settlements nor that there would be no benefits to rural facilities.

There seems to be a contradiction in the current spatial strategy for Stalbridge and the 18 Larger Villages. The adopted Local Plan directs 825 units to Stalbridge and the 18 Larger Villages. These 825 units are part of the District's *strategic* housing need, therefore these settlements are to accommodate more housing than might be considered as meeting just *local* need. The approach to settlement boundaries needs amending to allow the existing spatial strategy to be delivered as development must be allowed outside the settlement boundaries of the Larger Villages in order to deliver the 825 dwellings directed to Stalbridge and the Larger Villages. Given the nature of the housing market, and the varying nature and availability of sites and their respective constraints, it is likely that some Larger Villages are going to be more appropriate locations for delivering higher numbers than local need, whereas others may not be appropriate locations to even meet local needs. So it is imperative that planning for the Larger Villages is not done at the micro-level of local need.
