Please see your own Atkins report (on which the local plan and much subsequent work is based), table  4.3 in Atkins carries out a much more comprehensive assessment and comes to the conclusion that:
Area B Windyridge (ATK 15 in the Atkins report) should be excluded from further consideration because its very low score on sustainability (see para 4.81 of Atkins)
What are the additional infrastructure requirements that are likely to result from potential future development at Gillingham?

The southern extension at Gillingham has been carefully planned to both cater for the proposed development and to alleviate some of the existing infrastructure problems Bringing forward other sites located away from the southern extension will exacerbate existing problems, create new problems and dilute the viability of the Southern extension proposals. A more sustainable solution is to concentrate any further growth adjacent to the southern extension. This will actually strengthen the viability of the proposed development.
The idea of bringing development to Bay road which is only wide enough for 1 vehicle and provides only tortuous access to the town and absolutely no public transport options is at best ill conceived.
