

We agree with the conclusions in the Sustainability Appraisal in respect of Area H, The Crown Meadows/Bryanston Deer Park. We believe that the following issues should also be taken into account: 1.The DCC Landscape Impact Assessment recommends that any future development be limited to a small area adjacent to the built up area (within a dashed blue line) in order to avoid causing substantial harm to the significance of affected heritage assets.

- 2. Blandford is acknowledged as one of the finest Georgian Towns in the country and consideration of the contribution of the Crown Meadows to the significance of its setting is a critical matter, emphasized in statute and national policy.
- 3. The liability of surface water flooding is obvious and recognised. However, our ground water studies show that about half of the site proposed by the previous owners is subject to ground water flooding where the required 1 meter between the foundations and the underground services (sewers, electricity and gas etc.) is not achievable. Such studies have not been carried out and of course would only be valid if undertaken during severe flood conditions as occurred in December 2013 when the River Stour reached the level of 34 meters AOD at Blandford Bridge. Surface water reached a level of about 32 meters beyond the reference OAK Tree, a flood the size of which had not occurred in the previous 15 years. (See photo attached below.)
- 4. During the 5 years of consultation between 2010 2015, the residents of Blandford had consistently expressed their objection to any development taking place on the Crown Meadows in the strongest possible terms, concluding in a petition signed by almost 6,000 residents.
