If Sajid David approves the formation of the 2 unitary authorities, then this could be one of the last significant decision making processes for North Dorset District Council.

In terms of infrastructure, A roads in North Dorset are mostly deemed "unsuitable for HGV through traffic" via the Dorset Freight Network Route Map.

Dorset CC, Wilts CC, and BANES are attempting to engage DfT in including a Strategic route between the M4 and Poole in RIS2.

DfT announced on 23<sup>rd</sup> Dec 2017, a consultation process for a new Major Route Network.

Thesafeguards currently in place for an Outer Shaftesbury bypass and similar for Spetisbury and Charlton Marshall should not be lifted until it is clear whether these would be required to proceed with either of these important and recent developments.

To lift these safeguards at this time would be folly. The decision made by NDDC on this very important matter will be a legacy for the future of North Dorset, or a nail in the coffin for any hope of providing a much needed north/south route solution.
