In area D, there are significant difficulties associated with vehicular access to the area of The Wilderness. This is particularly so with any potential access from Hawkesdene and French Mill Lane. This is also an area which is used for recreational purposes and is of significant benefit to the wildlife. Any rise in traffic through Hawkesdene, as a result of development in the The Wilderness, will also exacerbate an already hazardous situation for pedestrians walking to and from Abbey View Medical Centre and, at specific times, Shaftesbury School.

14. What are the additional infrastructure requirements that are likely to result from potential future development at Shaftesbury?

Infrastructure is under considerable pressure currently, particularly in respect to traffic management. This is very much a 'lane' environment and, as such, there is a very limited passing capability and parking. The latter causes significant and serious safety issues for pedestrians, there being no suitable pavement or passing room. Additionally, French Mill Lane and Hawkesdene are used as main routes for HGV vehicles operating in the area, particularly from Wessex Water attending the sewage processing plant at Gears Mill. This aggravates an already difficult traffic negotiation situation, particularly where daytime, long-term, parking is increasing from work colleagues in the town; upper parts of French Mill Lane being used as a convenient unrestricted parking zone.
