#### **Dear Sirs**

Please find attached my response to your consultation. This consultation appears to be an attempt to avoid consultation. By making it difficult, secret and opaque it can be claimed that people don't care because so few responses have been received.

I have lived in and around Shaftesbury for most of my life and am appalled by what is happening to this picturesque historic town. There has been a complete failure to provide infrastructure (schools, health provision, etc) to match the huge number of houses that have already been built. There is yet more building in the pipeline on land that has additionally been given the go-ahead for development - but I note that there still will be no proper infrastructure and no jobs for all these additional people; I assume therefore that creating unemployment ghettos is an accepted principle here. Given the current situation, the idea that anyone is seriously considering granting permission for even more building around Shaftesbury beggars belief.

I could say a great deal more regarding housing nationally, use of brownfield sites, the boarded up houses index, lack of affordability and the mass "dumping" of unemployed people in rural communities where they have no prospect of ever becoming employed people. I have the impression, however, that no one with the power to do anything actually wants to listen.
