With reference to Area D (land between the A350 and French Mill Lane as identified on Map 8.2: Shaftesbury - Areas of Search:

1. The site sits on the ridge which is elevated above French Mill Lane, St James and the core of Shaftesbury and any development that would be proposed would be harmful to the Conservation Areas of Shaftesbury and St James and French Mill Lane.

2. The Wilderness is defined as a "Monument - Quarry - Post Medieval".

3. This site has a blanket Tree Preservation Order upon it and therefore the trees are protected in their own right.

4. The land formed on this site is old stone quarries, which has been worked for hundreds of years historically. This land is now completely overgrown and its topography is severe. The stability of the ground is suspect as the arisings from the quarries have been pushed down the hill historically and therefore the proposal for constructing any structures upon this land would be seriously questionable in terms of stability of this land.

5. Access to the site would be extremely difficult if it were to come through the Wilderness.

6. The biodiversity that exists on this site is exceptional.

7. There is a footpath that runs through the site which is heavily used by the general public, and indeed by ourselves. The views out across St James and Shaftesbury are delightful.

8. If this land were developed then it would prevent the School being able to extend their playing fields if they needed to do so in the future.

9. The impact upon the wider landscape on arriving towards Shaftesbury from the Lower Blandford Road would cause serious harm to the setting of Shaftesbury.
