

Geodiversity

Criterion C6 - Impact on geodiversity.

The Purbeck limestone group has an important association with the geology of the Jurassic Coast World Heritage Site. Working guarries in Purbeck have been known to yield important fossils, including dinosaur footprints. They are also of ongoing interest for the study of early Cretaceous stratigraphy. These interests should be acknowledged with the assumption that geologists and the Jurassic Coast Team hosted by DCC will respond positively to any opportunities to recover fossils or record and study unusual features if they are discovered. In terms of geodiversity there is a presumption in favour of an appropriate level of quarrying activity continuing in order to sustain these ongoing interests.

Criterion C8 - What is landscape capacity to accommodate proposed development.

In the zone of least landscape and visual impact so it will be how the area is worked which will determine its capacity. Small areas, quantities, progressive restoration and in short campaigns with low stockpiles is recommended. Removal of existing stock piles from visually sensitive edges is also recommended.

Criterion C9 – Impact on historic landscapes.

The local landscape bears the imprint of previous quarrying dating from the Roman period onwards. It could be argued that the present site would be a continuation of the process, and if the site is to be restored afterwards the impact would be limited in time anyway. In this case, the situation is complicated by the presence of a number of Scheduled Monuments in the area, notably a Bronze Age barrow at the site's south-west corner. I understand that the exclusion of part of the site in the vicinity of the barrow has been agreed with English Heritage to protect that monument's setting. If so, category C, if not category A.

Closest residential properties are coast guard cottages to south west, at approximately 380m. Other properties to north/west, approximately I km distant or more. Limited views of site.

Criterion C25 - Are the access proposals acceptable

Access proposed is via private tracks onto a public road through Worth Matravers and onto the B3069. This route is narrow in places and has areas of limited forward visibility. There are however sufficient areas of clear visibility with informal passing places for the small amount of traffic from the proposed quarry to be accommodated safely. There is also safe access onto the B3069. The stipulated assessment criteria mean that this site has been given a B rating as the site necessarily means that HGVs will pass through relatively narrow roads within an existing settlement. However, extraction at this site has been operational for some time and there is no indication that there will be any significant increase. Provided there is no increase in HGV traffic over the current operation, the very low and sporadic nature of the traffic means that there is little adverse impact and the site could be considered to have a C rating.
