In revised Policy Paragraph 8.2.4, lines 2 to 5 you state:

'In Purbeck the Council may support employment and tourism accommodation. The NPPF also supports the re-use of rural buildings for housing where it would lead to an enhancement of the immediate setting.'

There are two issues here:

- 1. You state that you '....may...' support employment and tourism accommodation. This allows you at your discretion to support, or not to support, employment and tourism accommodation. I believe that this should be a positive statement that you do support these essential elements of the community.
- 2. You have clearly discriminated between what <u>you</u> (may) support (first sentence quoted above) and what the <u>NPPF</u> supports (second sentence quoted above), with the obvious inference that you do not support the NPPF's guidelines for the re-use of rural buildings for housing. This document is <u>your</u> Policy <u>you</u> should reflect the requirements of the NPPF (as noted by the Inspector).
