Within the healthcare section of this plan there is no mention of the viability of services for Shaftesbury. Gillingham is mentioned as potentially needing an additional surgery but despite the lack of provision in the current phase of building, it appears that none is to be made for Shaftesbury for the future either.

We would like to express our concerns regarding the North Dorset Local Plan 2011-2026. Our experience to date, with the ongoing new build occurring in Shaftesbury, is that it has resulted in a significant increase in pressure on health care provision, and we now find ourselves to be at capacity. Further building without investment in the healthcare infrastructure is unacceptable. Our current premises are fully occupied and we have no option to expand on our current site; access and car parking are becoming a major issue. We have no funding to expand our current site or to fund a new build.

There is also the issue of the percentage of social housing which has clearly increased since the original planning. This again puts further pressure on provision of care as these patients tend to have greater medical and associated needs. They often do not have transport and struggle to gain employment in such a rural and isolated area. This has a negative impact on their health which then results in high intensity need, both from health and social care.

Additionally, the land put aside from the last planning agreement lies derelict and will most likely be sold for further development. This has not benefited the local community in any way, shape, or form and there has not been any tangible employment for the local community from the plan so far.

In essence we are extremely unhappy with the plan. Without any dedicated financial provision for healthcare to support the additional patient burden which already exists, let alone the future increase, the services in Shaftesbury will come under intolerable strain. We also have concerns relating to the poor transport infrastructure around Shaftesbury and the negative health impact that this has, along with the lack of local employment opportunity, again creating a greater health need amongst the community.

None of these issues seem to have been considered within the plan other than for the Gillingham area. There is a great deal of development already happening in Shaftesbury and support services seem to have simply been ignored.
