By stating that ‘these important community buildings should be retained and allowed to modernise and adapt to continue to meet the community’s needs (either in their current location or through suitable alternative provision in the Neighbourhood Plan area)....’ it is effectively stating that the sites cannot be disposed of unless a suitable alternative provision is made within the town. it is not the role of a Neighbourhood Plan to specify that specific services must continue within the town. By stating that a site should be used to provide a community service and that the redevelopment of the site for alternative purposes will be strongly resisted, the NHP could frustrate the strategic rationalisation of a specific service which takes into account a wider overview of service provision.

It is understandable why the plan would want to retain a service within the town however as drafted policy 10 is preudical to future service design. Whilst it allows for reprovision and redevelopment it does not allow for a circumstance if reprovision is not a viable option.
