North Dorchester Garden Communities Bid

On behalf of the North Dorchester Consortium I would like to confirm our strong support to West Dorset District Council in its bid to Garden Communities Programme.

The North Dorchester Consortium comprises Grainger plc and Persimmon Homes plc, who are working to deliver a long-term solution to Dorchester's future housing, employment and infrastructure needs. Both these companies are working collaboratively to promote a single proposal and vision for North Dorchester.

As you know, the Consortium has recently consulted on its response to the Council's vision for North Dorchester, as set out in its Preferred Options Plan. It is striking how aligned the Consortium and the Council are in respect of achieving a comprehensive and high quality design for what will be the long term growth option for the County Town.
