Gill Smith Maj/16/2 - missing text Question 6

Dorset County Council notes the proposed change to Policy 16 to include reference to a new strategic housing site to the south east of Blandford St Mary in place of the site to the west of Blandford Forum.

The introduction of text which specifies the need for the identification of a safeguarded route for the Charlton Marshall and Spetisbury Bypass as part of the development of the land to the south east of Blandford St Mary is supported.

This major highway scheme is currently an aspiration contained in the Bournemouth, Dorset and Poole Local Transport Plan 3 the route of which is retained as a long term reservation in anticipation of its construction beyond 2026.

In drawing up more detailed proposals for this scheme in Part 2 of the Plan, North Dorset District Council should also include as requirements:

- Connectivity to the town centre for pedestrians and cyclists, including a safe crossing of the A354 that will also benefit users of the North Dorset trailway.
- Site access a new access on A354 south west of Badger roundabout and a second access on A350 south of Badger roundabout to provide site permeability.
