Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

We are hoping to promote local beers, ciders and wines to our guests visiting from all over the country. We have occasional barbecues and visiting food trucks weekly for our visitors and also sunflower walks during July and August which are open to the general public. A glass of wine overlooking a field of sunflowers and wild flowers we hope will enhance our visitor experience.

b) The prevention of crime and disorder

We do not have large capacity and will have limited supplies of wine, beer and cider on site. Our guests are mainly families with small children.

c) Public safety

Our staff (partners) will be trained to be aware of potential issues. All partners and staff are First aid trained.

d) The prevention of public nuisance

The farm is situated away from other habitation, and we will be unlikely to play music of any kind. Our campsite does not allow loud music and all our sites are off grid.

e) The protection of children from harm

Children will be present at times all day but accompanied during the times when alcohol will be sold and we will adopt Check 25 procedure.


