

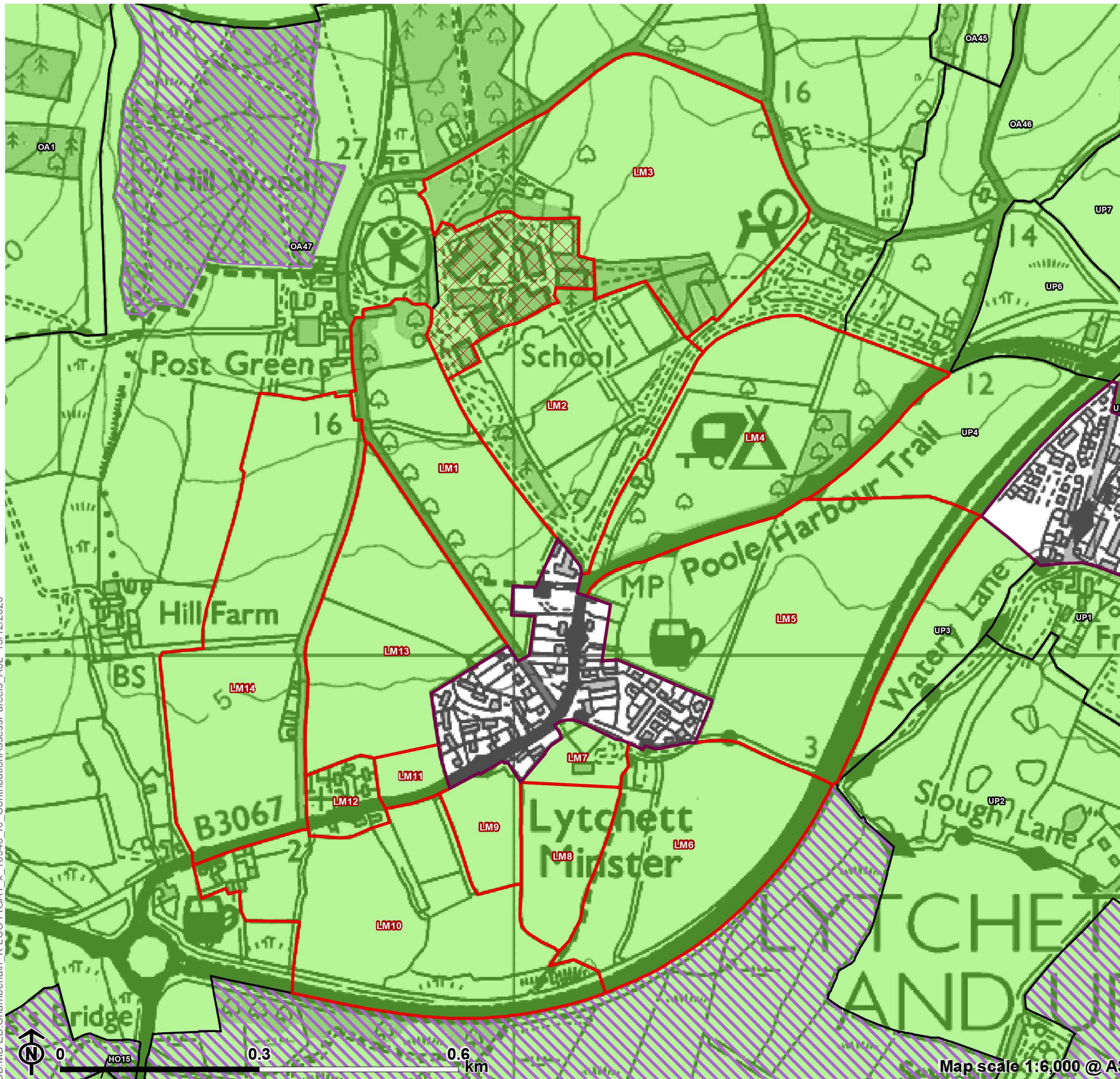

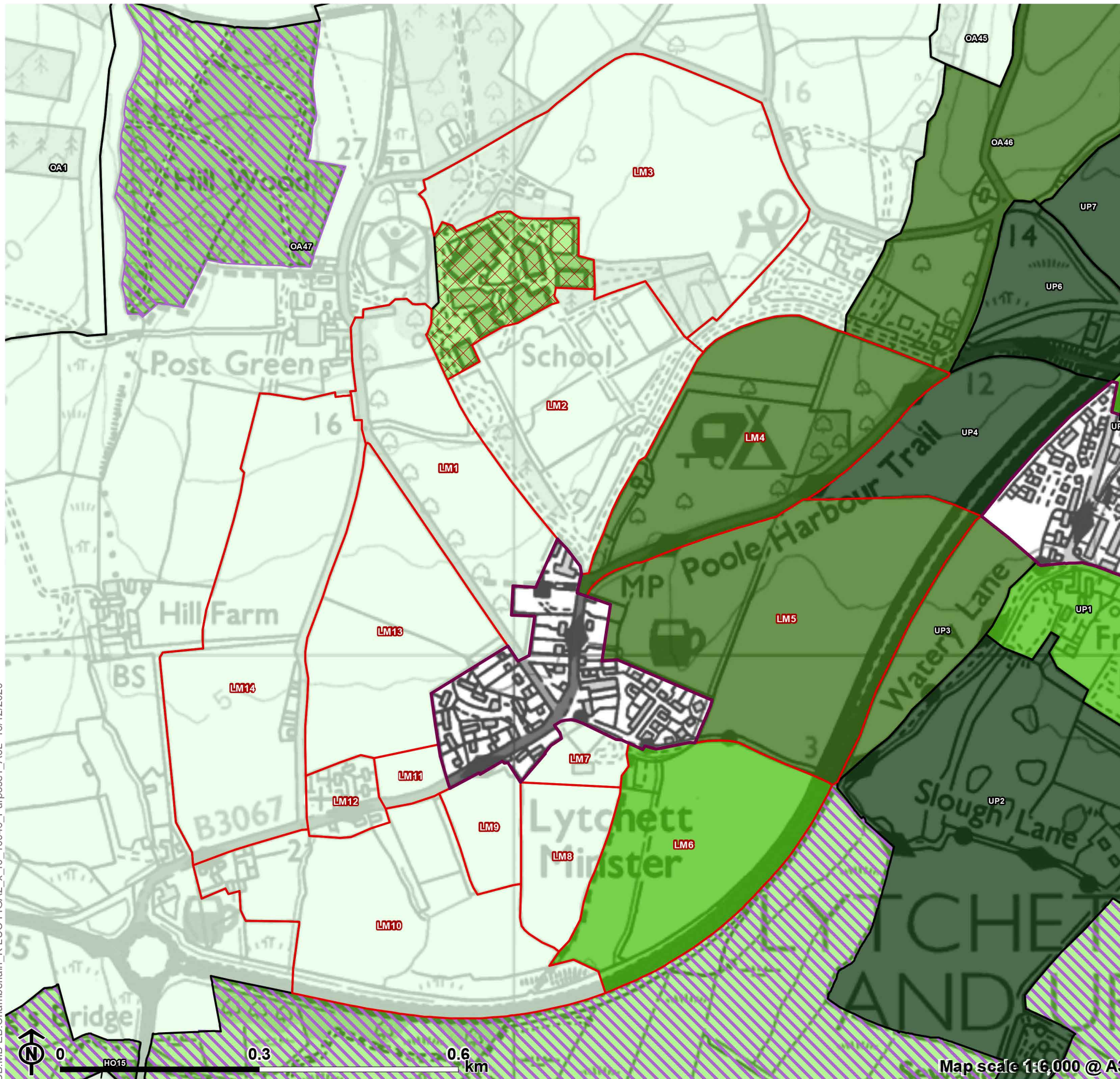

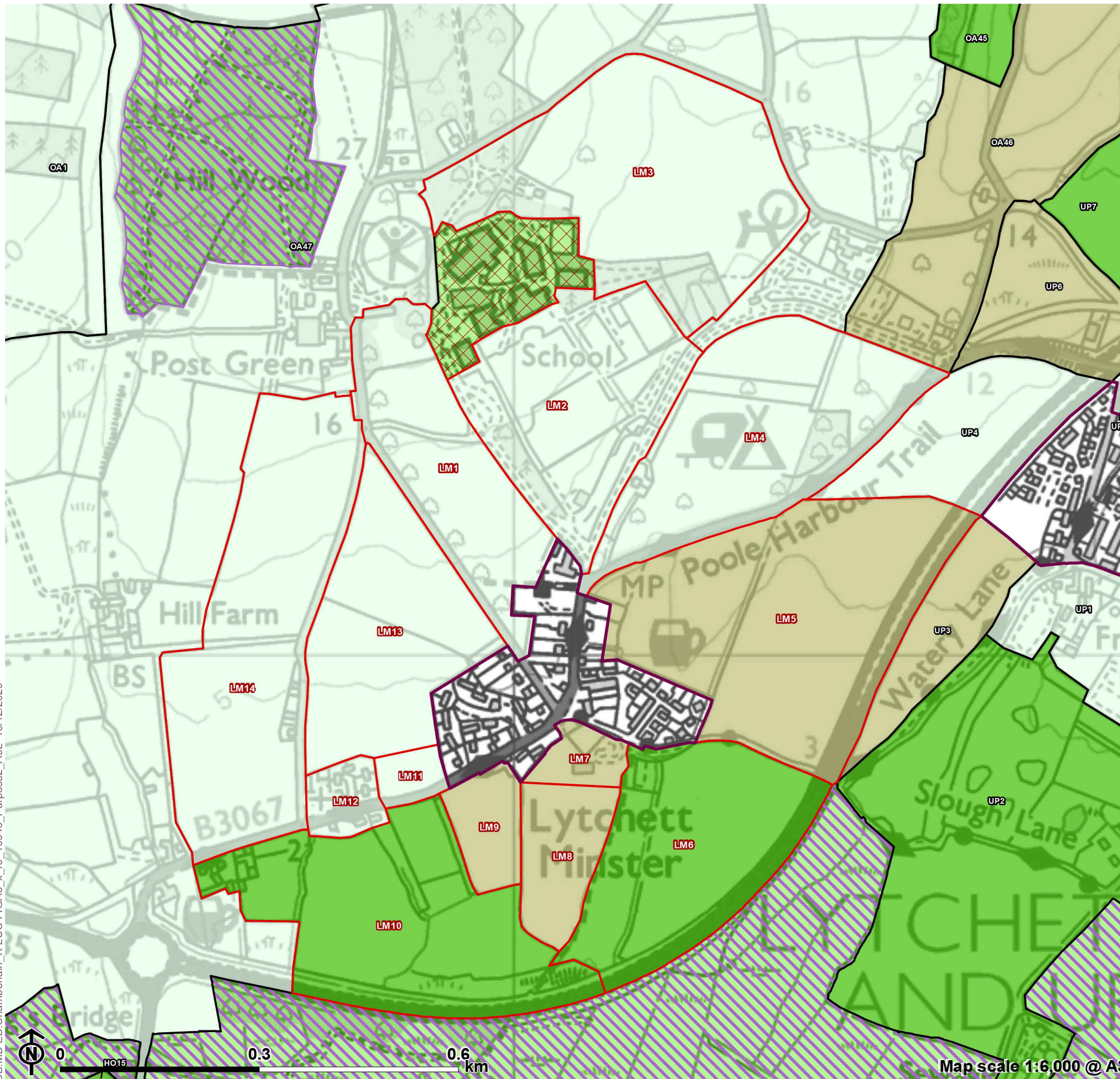

Lytchett Minster**

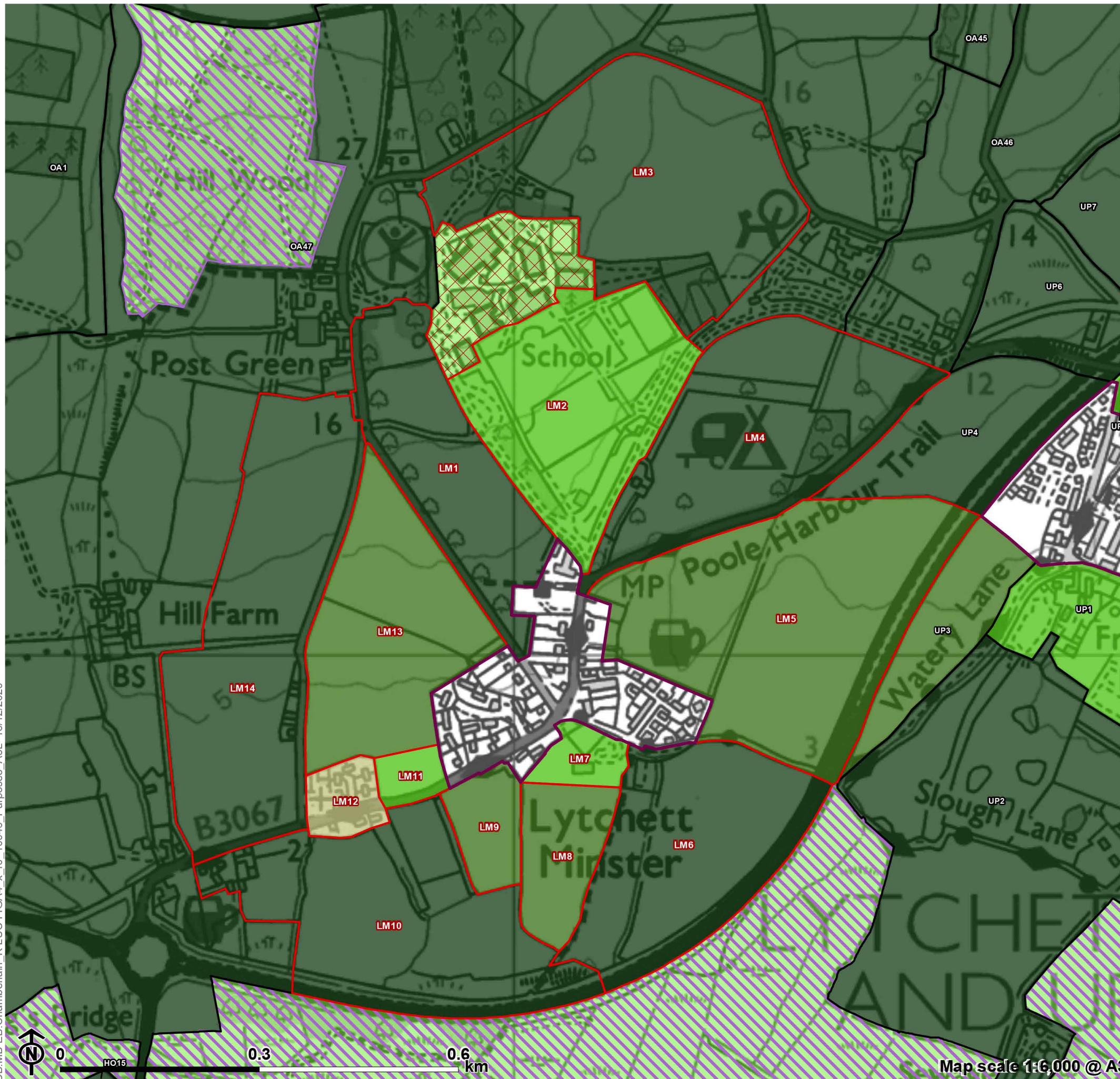

Lytchett Minster**

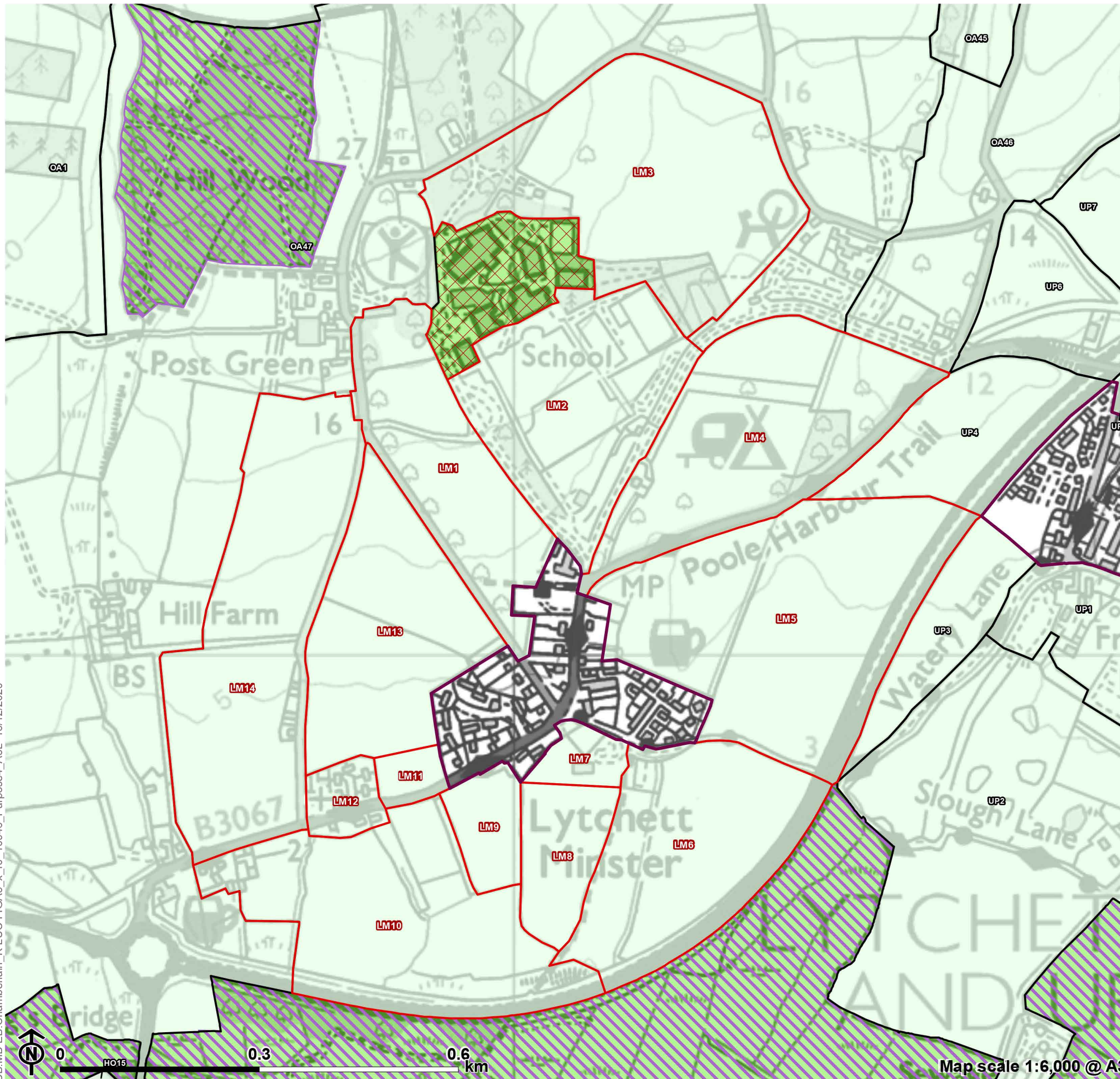
