Your Comments

Please provide alternative evidence or reasoning to support your view(s) where possible.

- 1. The draft charging schedule as proposed clearly favours the market towns to the detriment of the rural areas. Whilst understanding there is a much smaller need for housing development in the rural area. The amount set does not match the main development areas and there is a clear bias.
- 2. The retail development charge outside the town centres again shows a bias towards the towns. The rural community is already severely disadvantaged, with cuts to public transport and unlike town dwellers are obliged to pay for parking. Local towns people have more public transport links and can walk to the retail outlets.
- 3. Town centres within the main development areas have areas rated at zero for retail development, whilst all areas outside of these are charged at £70 (subject to size etc.). It would be more equitable to have the central areas of the larger villages given the same opportunity of having a nil charge area to encourage retail within that area. This could have the benefit of reducing our carbon footprint and the number of road trips. The issue of the need to build the infrastructure to cater for these developments is the responsibility of any developer and should not be used to discourage the needs of the rural community.
- 4. The proposed areas of zero charging for the villagers should be agreed with the relevant Town and Parish Councils. It is clearly understood that retail development in the villages will be low, but again it should be encouraged. The current charging proposals do nothing for the rural community.
- 5. These proposals, along with others made by the County Council are further isolating the rural communities and will continue to allow them to wither.
- 6. Where the charges are appropriate, I note and agree with DCC's view that the charges are somewhat low.
