Thank you for providing Highways England with the opportunity to comment on the proposed Main Modifications to the Local Plan, and the CIL preliminary draft charging schedule.

Our comments below reflect the current guidance contained with DfT Circular 02/2013 "The Strategic Road Network and the Delivery of Sustainable Development" and the National Planning Policy Framework.

Local Plan Part 1 - Main Modifications - Policy 17

Para 8.85 of the Submission plan sets out that capacity issues on the A303 would need to be resolved for the growth of Gillingham beyond 2026. Recent trip generation and gravity modelling for the emerging South Gillingham urban extension, consisting of 1800 homes and employment, shows that the number of two way peak time trips onto the A303 exceeds the assessment threshold. Given that Policy 6 of the Main Modifications now proposes a development horizon to 2031 and an increase in development to at least 2200 homes at Gillingham, Highways England is of the view that the policy for Gillingham urban extension (Policy 17) should now include explicit reference to the need for the proposal to assess the impact on the safety and capacity of the A303 and to provide for mitigation to offset any potential severe impacts.

The Government has published the Road Investment Strategy (RIS) for the period 2015 to 2020 and this includes the intention to upgrade the A303 to dual carriageway as part of a long term commitment to create a new Expressway to the South West. However, this section of the A303 is already dual carriageway and has grade separated junctions and would not therefore be considered for further improvement within the current RIS period.

A programme of improvements to the whole of the A303 beyond the current RIS period is not yet known and it is possible that sections such as this could be beyond both 2026 and 2032. Therefore any safety or severe capacity impacts on the A303 in the interim arising from strategic development should

be addressed by the developer.

Highways England therefore recommends that Policy 17 should be amended to include the new time scale of 2031 and a new bullet under Infrastructure to read:

➤ "Subject to the outcome of the Traffic Impact Assessment and road safety reviews, to improve junction/s with the A303 to address safety and/or any potential severe capacity impacts that the development is demonstrated, through assessments submitted with planning applications, to give rise to."
