West Dorset, Weymouth and Portland Community Infrastructure Levy (CIL) Modifications Consultation, March 2015- Representations on behalf of Bourne Leisure Ltd.

Please find attached comments on the West Dorset and Weymouth & Portland Borough Community Infrastructure Levy (CIL) Modifications Consultation document on behalf of Bourne Leisure Ltd.

We previously submitted comments on behalf of Bourne Leisure Ltd. by letter of 23 July 2012 in regard to the CIL Preliminary Draft Charging Schedule (July 2012), where we advised that a definition of what comprised "dwellings with restricted holiday use" should be included within the Preliminary Draft Charging Schedule and should clearly state that this excludes holiday accommodation such as chalets and caravans sited in holiday villages and purposebuilt resorts. We also considered that it should be made clear in the Charging Schedule that such visitor accommodation has a zero CIL rate.

We subsequently commented on behalf of Bourne Leisure Ltd. by letter of 17 December 2012 to reflect the fact that no definition had been included, and to make clear that all tourist accommodation should be excluded from the definition of "dwellings with restricted holiday use" and given a zero CIL rate in the Charging Schedule.

Bourne Leisure therefore welcomes the inclusion of a definition within the Schedule, but as set out on the attached form, considers that the definition should be redrafted to clearly state that the definition excludes all tourist accommodation (such as chalets and caravans) which is sited in holiday villages and purpose-built resorts.
