1. Access to and from the proposed development

Access from the site onto Salisbury Road would be too close to the Salisbury Road/Bypass roundabout.

The contour of the land on the Salisbury Road approaching the roundabout is such that Vehicles travelling west on the Salisbury Road would be unable to see emerging traffic from the proposed site.

Any access from the proposed site directly on to the Blandford bypass would require a roundabout or traffic signals between the Salisbury Road and Wimborne road roundabouts. On frequent occasions the bypass becomes congested owing to the volume of traffic waiting to cross the Wimborne roundabout . This leads to some local traffic choosing to drive through the town centre to avoid the congestion.

The addition of a further roundabout or traffic lights would exacerbate such congestion. By bringing the bypass within the occupied town boundary its use as a bypass is compromised.

A development of 400 houses will potentially result in as many as 800 additional vehicles To the immediate area.
