

## Decision Statement

---

**On behalf of Dorset Council, 5 May 2020**

At the meeting of the Cabinet on 5 May 2020, Dorset Council has taken the decision to make the Sutton Poyntz Neighbourhood Plan (as modified in accordance with the Examiner's recommendations) part of the development plan for the Sutton Poyntz Neighbourhood Area.

### Reasons

---

In May 2019 Weymouth Town Council submitted the Sutton Poyntz neighbourhood plan and supporting evidence to Dorset Council. An independent examiner was appointed, and their report was received in October 2019. In summary, the examiner's report concluded that the Sutton Poyntz Neighbourhood Plan, subject to some modifications, would meet the Basic Conditions and other legal requirements.

Dorset Council considered each of the recommendations and modifications contained in the examiner's report and agreed the amendments in an Executive Decision Statement 27 November 2019. Dorset Council issued its decision which was in agreement with the examiner's findings, and that the plan as modified should proceed to referendum.

Dorset Council held a referendum on 13 February 2020. More than half of those voting in the referendum voted in favour of the plan. No other issues have come to light which would suggest that the council should decline to make the plan.

### What this means for the Sutton Poyntz Neighbourhood Plan area

---

In England, development plans are used to set out the planning policies for the development and use of land.


Planning applications are determined by local planning authorities such as Dorset Council. Planning decisions are made in accordance with the adopted development plan, unless material considerations indicate otherwise. The neighbourhood plan forms part of the development plan for Sutton Poyntz Neighbourhood Area alongside the adopted West Dorset, Weymouth & Portland joint local plan.

The policies in the neighbourhood plan are in general conformity with the strategic policies of the local plan. Therefore the policies contained in the Sutton Poyntz Neighbourhood Plan will take precedence over the non-strategic policies in the adopted local plan when decisions are being made on development proposals.
