### Hi Jo

Apologies for not getting back to you as soon as I had hoped.

In response to the two points in question:

- 1. Camelco site. I appreciate Steve Wallis' position in needing to see details before he can express an opinion on the virtue of planting to mitigate impact. At the same time Paul (presumably Wyeth) has endorsed Kevin Morris's report. All we have done is ask the Council's conservation team to reassure itself on the policy and the evidence which underpins its provisions. How they do that and reconcile this as they think necessary with Steve's position is up to them but they have responded to our advice and there is nothing more we would expect or add on this issue.
- 2. Traffic Management measures. We tend not to be involved in such schemes as that envisaged so it is difficult to offer up some case exemplars. Given that the policy refers to liaison with the highways authority and it is their protocols in question one might imagine that liaison would allow them to identify schemes in the county which are successful examples. There is presumably no reason why the consultant should not engage in such a conversation to inform their conceptualisation (if they havn't already) and hopefully they are familiar with this kind of work in historic rural contexts. Thank you for your Regulation 14 consultation on the Milborne St Andrew Neighbourhood Plan.

We can summarise our comments as follows:

- 1. Previous advice in response to previous consultation exercises associated with the Plan's preparation have focused on the need for evidence to substantiate the allocation of any site(s) for development relative to their potential for impact on designated heritage assets. We note now that the Plan is proposing to allocate only one site for development Policy MSA5, Camelco Site. This is in recognition of its brownfield site status and the criteria for development makes provision for planting as screening to mitigate any potential for visual impact on the setting of Weatherby Castle. We would encourage liaison with North Dorset District Council conservation team and as necessary the County Archaeologist to endorse the suitability of this provision as a response to potential impact on the setting of the Castle, and verify the April 2018 Heritage Assessment which provides underpinning evidence.
- 2. Policy MSA2 identifies traffic management measures set out in Table 3 and shown in the Concept Masterplan in Appendix 2. These could introduce an essentially urban flavour to the rural character of the village and unwittingly cause harm to the character and appearance of the Conservation Area, and run counter to Dorset County Council's Rural Roads Protocol. There is no reference to any consideration of the Conservation Area or the Protocol in the supporting text to the policy or the Concept Masterplan. We note the intention of the Parish Council to pursue the suggested measures with the Highways Authority and we would therefore recommend that further exercises ensure that the preservation and enhancement of the historic character of the village is prominently factored in to any design review/ratification process.

- 3. Given our comments above, we particularly support the intention of the Parish Council to work with the local planning authority to re-appraise the Conservation Area (policy MSA3).
- 4. We are also particularly pleased to note the local vernacular design guidance (Table 10) and associated policies MSA13 & 14.

Overall, our congratulations to your community on the preparation of its Plan. We look forward to seeing how our comments above have been addressed at the subsequent Regulation 16 consultation, and wish the community well in the making of its Plan.

## Milborne St Andrew Neighbourhood Plan Consultation 23 July – 3 September

Milborne St Andrew Parish Council and the Neighbourhood Plan Group are consulting on the presubmission draft of the Milborne St Andrew Neighbourhood Plan. We are writing to you as a statutory consultee, local council, local service provider, local landowner or because we have identified that you may have a potential interest in the plan. This is your chance to make your views known, so that changes can be made (if appropriate) prior to the plan's submission for its examination.

When finalised, the plan will be a key document in determining future planning applications in Milborne St Andrew. It identifies the locations where new development will be supported, and sites where development would not be appropriate. In particular, it allocates land opposite the Milborne Business Centre to be the main site where new homes, plus some small-scale workshops, a new Pre-School and Branch Surgery, will be built. At the time of going to press, we have been notified that there is unlikely to

be funding for the Branch Surgery, so this element may need to be reconsidered and you are welcome to give your views on this. We are also showing the concept plan received for Homefield (which was not available at the time of the November consultation) – this site has not been included in the Plan as the Neighbourhood Plan Group did not consider that it would be a better option, based on the evidence available, but you are welcome to comment on this as part of the consultation.

The Plan also includes design standards so that developers and their architects have a clear steer as to the type of development will be supported. This includes more generous parking standards for all new development to comply with. It sets out the priorities for improving local roads and footpaths, to make the village feel safer and easier to walk around. By having this in place, developers will know what measures are expected and can factor this into their plans, and the Highways Authority will also know what measures the community wish to see put into place. And flooding issues also feature, with a more rigorous approach to assessing flood risk and drainage solutions proposed than would otherwise happen (particularly on smaller sites where flooding issues can sometimes be overlooked).
