#### LOCAL NEED AREA - SIXPENNY HANDLEY

#### 1.0 DESCRIPTION OF LOCAL NEED AREA

Sixpenny Handley is a large village in north Dorset, situated on Cranborne Chase ten miles to the north east of Blandford Forum. It is fairly isolated, lying on rising land above a dry valley which contains the River Allen in its lower reaches. The historic core of the village, along the High Street, rises to St Mary's Church; the A354 Blandford to Salisbury Road passes about a mile away to the South East of the village; crossing this is the Ringwood to Shaftesbury Road which runs north-westward through the centre of Sixpenny Handley. There was rapid housing development in the south of the village in the 1980s. There is a substantial village hall, a recently constructed extension to the playing field and pavilion and a school.

#### 2.0 SUMMARY OF PROVISION AND QUALITY OF OPEN SPACE

#### 2.1 Open Space within Sixpenny Handley

The Map shows the location and typology of open space within Sixpenny Handley. The following sites have been mapped; many were included in the quality assessments and their detailed scores are held on the GIS database and should be referred to as required.

#### 2.2.1 Active Sports Space

There no significant quality issues with the sport spaces within Sixpenny Handley, the multi functional sports facility is in excellent condition.

The children & young people's spaces are of good quality.

The Orchard amenity area is the only informal space that has been assessed in Sixpenny Handley, the site is in very good condition.

#### 2.2.4 Natural & Semi Natural Space and Green Corridors.

No sites of Natural & Semi Natural Green Space were identified as part of the study.

#### 2.2.5 Recreation Grounds and Public Gardens

The Common Recreation Ground with one senior football pitch provides the formal park for the area, it is in reasonably good condition, but sustained future management and maintenance is required.

There is a first school in the village but the playing field was not assessed as part of this Study.

#### 3.0 SUMMARY OF ACCESSIBILITY TO OPEN SPACE

#### 3.1 Overall access to open space

Section 5 of the report outlines access standards to different types of open space within the Local Need Area, a summary of the main standards is shown in Table 2:

The accompanying maps show local access standards for the various typologies (i.e. Space for Children and Young People, Amenity Open Space, Natural and Semi Natural Green Space, Active Sports Space and Recreation Grounds and Public Gardens).

#### 3.2 Access to different types of open space

Table 3 makes observations on access to different types of open space within the catchment area, using the adopted access standards, as shown in Appendix 1.

There is only one amenity green space in the east of the village which means technically the eastern end is less well served, but it has access to the Recreation Ground.

#### 4.0 FINDINGS FROM SURVEY AND CONSULTATION

#### Citizen's Panel

9 people living in Sixpenny Handley responded – placed in Rural Sub Area (51 in total). People living in the Rural Sub Area are more frequent (compared to the district as a whole) visitors to local playing fields, recreation footpaths, spaces to enjoy nature and wildlife and sports centres and community halls, and less frequent visitors to local recreation ground or park, cycle paths, coast and beaches and swimming pools and health and fitness centres.

The types of open space respondents would like to see more of in the Rural Sub Area are children's play areas and space for teenagers.

The most important attributes of open space are that they should be easy to get to, safe and free from noise and unsocial behaviour. The most important facilities to have in nearby open space areas are: teenage facilities, trees and toilets. Around half of respondents would like to use open spaces near them more often: more information would be important in encouraging this.

Local Areas of Open Space in Sixpenny Handley

The most frequently visited local areas of open space in Sixpenny Handley are the playing fields and footpaths and Garston Wood.

Comments made highlighted the following:

- Re public footpaths:- when using public footpaths across fields a) All stiles should have a section which can be lifted to allow dogs to go through b) Where livestock are in fields crossed by public footpaths the paths should be fenced off
- Need local maps of local woodland and footpaths etc.

#### **Summary of Provision**

The principal site is at the western end of the village with the Common Road Recreation Ground – a large open site with a gentle slope toward the village hall incorporating, play area, two tennis courts, a fenced lawn bowls area, a sports pavilion, senior football pitch (home to Handley Sports FC: 1<sup>st</sup>, 2<sup>nd</sup> and mini) and a cricket pitch (Sixpenny Handley CC). It is managed by a sports association for football, cricket, tennis and bowls club.

#### Sixpenny Handley with Pentridge Parish Council


The parish council identifies a need for more areas for young people, particularly skatepark and teenage shelter. Not known if there is spare capacity at the village hall or schools. The most used open space in the parish is the recreation ground and pavilion. The Sump on Dean Lane is overgrown.

The recreation ground, especially the football and cricket pitches, the tennis courts and the pavilion are under-utilised. This raises issues for the Parish Council in terms of maintaining and paying for the facilities - how can use and income be increased and vandalism be minimised?

#### 5.0 QUANTITY OF OPEN SPACE

#### 5.1 Quantity standards for open space

Section 5 of the report outlines the quantity standards for open space within the District; a summary of these draft <u>minimum</u> standards is shown below:



#### 5.2 Quantities of different types of open space

These standards have been applied at a local level to determine the provision of different types of open space across the adopted minimum standard, this is summarised in Table 4 which shows:

- the existing quantity of open space (existing provision);
- the required quantity of open space for the population of the area (required provision);
- the surplus or deficiency of open space (in m² and acres);
- Supply against the standard.

#### 5.3 Key Points: Quantitative Provision of Open Space in Sixpenny Handley

Sixpenny Handley is a small village and probably adequately served, especially given the issues of under use of facilities at the Recreation Ground. Technically it is underprovided with space for children and young people and natural green space (there is none actually in the LNA).

#### 6.0 ISSUES ARISING IN SIXPENNY HANDLEY

- The village has a large recreation ground with many new facilities and there is scope to make greater use of these
- There is a shortage of facilities and activities for teenagers here, as elsewhere in the district
- Most facilities and sites appear well maintained.
