LOCAL NEED AREA - THREE LEGGED CROSS

1.0 DESCRIPTION OF LOCAL NEED AREA - THREE LEGGED CROSS

Three Legged Cross lies around the staggered junction of the B3072 Three Legged Cross to West Moors road and the C2 Ashley Heath to Horton road. The area is one of scattered housing and market gardens in level countryside, centred around a small area of denser housing forming a distinct settlement. Apart from this settlement, and the nearby industrial estate at Woolsbridge, the area forms part of the South East Dorset Green Belt. Three Legged Cross has limited facilities, including a good quality village hall, First School, pub, church and chapel, shops and garage. Much of the housing in the settlement is recent. This recent development has given rise to a rapid population increase from 940 in 1981 to 1,520 in 1991.

Three Legged Cross has a recreation ground, but this is separated from the settlement by the busy Three Legged Cross Road, and is not close to any of the main housing, with the result that it has suffered from under-use, misuse and vandalism. An extension has recently been made to the recreation ground between Earles Road and Three Legged Cross Road to open it up to make it a safer place to use. Facilities for teenagers – a skate ramp – have also been provided.

2.0 SUMMARY OF PROVISION AND QUALITY OF OPEN SPACE

2.1 Open Space within Three Legged Cross

The Map shows the location and typology of open space within Three Legged Cross. The following sites have been mapped; many were included in the quality audit and detailed scores of the assessments are held on the GIS database and should be referred to as required.

2.2 Quality of sites in Three Legged Cross

In the following lists 'n/s' means 'Not scored'.

2.2.1 Active Sports Space

Magpies Football Club	59.9 %

The Magpies Football Club requires maintenance, the fencing around the outside of the site needs repairing. The pitch has problems around the centre circle and goal mouths, it will suffer without drainage in the winter.

2.2.2 Space for Children and Young People

The site at Door Step Green is in good condition, but the skate ramps at the
recreation ground require improvements. There is graffiti and evidence of misuse
apparent across the site; the location of the facility is very secluded which
promotes anti social behaviour.

In general, the management and maintenance of amenity green spaces across the area was found to be good. The following sites offer opportunity for improvement;

- Bay Close amenity greenspace (41.6%), improved maintenance required
- Greenlink LAP (66.6%), newly installed play equipment requires higher maintenance
- Fryers Road LAP (64.3%), improved maintenance required.

In general, the management and maintenance of Natural & Semi Natural Green Space across the area were of reasonable condition, although higher maintenance is required to bring them up in quality. No on site scores were included within the audit for these sites.

2.2.5 Recreation Grounds and Public Gardens

• Three Legged Cross Recreation Ground requires significant improvement to bring in line with an acceptable quality for competitive sport.

The school in Three Legged Cross was not quality assessed. It should have a future role in providing for formal sport and recreation. School sites are generally of better quality, as they are secure and generally have some sort of on a site presence in the form of caretakers or management.

3.0 SUMMARY OF ACCESSIBILITY TO OPEN SPACE

3.1 Overall access to open space

Section 5 of the report outlines access standards to different types of open space within the Local Need Area, a summary of the main standards is shown in Table 2:

3.2 Access to different types of open space

Table 3 makes observations on access to different types of open space within the catchment area, using the adopted access standards, as shown in the accompanying maps.

4.0 FINDINGS FROM SURVEY AND CONSULTATION

Citizen's Panel

74 people living in Verwood (which includes Three Legged Cross) responded to the Citizen's Panel Survey; for analysis, placed in Northern Sub Area (103 in total). People living in the Northern Sub Area are more frequent (compared to the district as a whole) visitors to: local recreation grounds, recreation cyclepaths, spaces to enjoy nature and wildlife and sports centres and community halls, and less frequent visitors to swimming pools and health and fitness centres.

The types of open space respondents would like to see more of in the Northern Sub Area are space to enjoy nature and wildlife and space for teenagers. The most important attributes of open space are that they should be easy to get to, safe and secure, with a range of facilities. The most important facilities to have in nearby open space areas are: toilets, dog bins and seats.

Two thirds of respondents would like to use open spaces near them more often: more information and if facilities and open space areas were perceived to be safer would be important in encouraging this.

Most Visited Local Areas of Open Space by residents in Verwood/Three Legged Cross

Residents living in Three Legged Cross are particularly likely to visit Moors Valley Country Park, Potterne Park in Verwood. Other areas often visited include the New Forest nearby, local beaches, Hengistbury Head and Dewlands Common. The overwhelming reasons for visiting these areas are to go for a walk and to visit areas of nature interest and value.

Summary of Provision


There are two main sports sites:

Magpies Football Club, Three Legged Cross: a grass playing field with 2 football pitches, and Three Legged Cross Recreation Ground, a grass recreation ground with informal pitches and temporary lorry container for storage of nets etc/changing facilities surrounded by mature trees. There is also a skatepark on this site.

5.0 QUANTITY OF OPEN SPACE

5.1 Quantity standards for open space

Section 5 of the report outlines the quantity standards for open space within the District; a summary of these draft minimum standards is shown below:



5.2 Quantities of different types of open space

These standards have been applied at a local level to determine the provision of different types of open space across the adopted minimum standard, this is summarised in table 4 which shows:

- the existing quantity of open space (existing provision);
- the required quantity of open space for the population of the area (required provision);
- the surplus or deficiency of open space (in m² and acres);
- Supply against the standard.

5.3 Key Points: Quantitative Provision of Open Space in Three Legged Cross

Three Legged Cross has sufficient open space against the proposed standard, apart from a slight underprovision for space for children and young people.

6.0 ISSUES ARISING IN THREE LEGGED CROSS

- Three Legged Cross is a compact little linear settlement. The southern part of the LNA is the best served with the Recreation Ground and the youth facility at the rear, although with poor access. Improving the access by extending the recreation ground at the front to open up the whole site and improve access is welcomed.
- The Lower Common is a popular area for informal recreation.
- Generally there appears to be sufficient play provision for the village, although securing additional use of the school could help to make play/sport opportunities more accessible to children living at that end of the village.
- The football pitch on the heath Magpies Football Club is an unusual facility within East Dorset, and is very well used.
- No other issues identified.
