LOCAL NEED AREA - WEST MOORS

1.0 DESCRIPTION OF LOCAL NEED AREA

West Moors lies on the north-western side of the shallow valley of the Uddens Water and its tributary, the Mannington Brook. South of Uddens Water the land rises again to the ridge on which Ferndown stands. The A31 Ferndown Bypass, following the open land of the Uddens valley, is a further feature separating West Moors from Ferndown. West of the Mannington Brook the land rises across the lower slopes of the Holt Heath National Nature Reserve.

Most of West Moors is modern, and it contains few houses built before the end of the last century. The settlement is surrounded by the South East Dorset Green Belt, whose boundaries were defined in the Local Plan for Ferndown, West Moors and West Parley in 1989. The population contains a relatively high proportion of elderly people, but there are also a significant number of children among the remainder of the population. The needs of both groups are reflected in the local facilities.

The proposed route for the West Moors Bypass will take part of the existing Fryer Playing Field, restricting the use of the remaining land, and will run through and largely sever from it a substantial additional area which was recently purchased to provide an extension to the playing field. While all this land - other than the strip to be taken for the road - will remain as public open space, its usefulness and extent will be diminished. Additional land has been designated to provide adequately for the extra playing fields long planned for this area. This will adjoin other land recently acquired for open space to the rear of Garden Court and together these will form an area usable for formal and informal recreation.

The Local Plan also states that, in the long term, it was expected that a new sports pavilion would have been provided to serve the extended Fryer Field. This new pavilion will still be required, but will need to be sited further south so that it can easily serve the whole of the Playing Field area including the new land north of Riverside Road.

2.0 SUMMARY OF PROVISION AND QUALITY OF OPEN SPACE

Three specific stand alone Active Sport Spaces were identified in West Moors however sport facilities that form a part of a larger multi function sites have been identified in Recreation Grounds and Public Gardens. The two facilities that have been assessed are in reasonable condition.

The play provision is poor in the area, the facilities require higher management and maintenance to cope with the level of use. Shaftesbury Road and Fryers Playing Field require urgent attention.

In general, the management and maintenance of amenity green spaces that were assessed across West Moors is adequate. A number of sites offer opportunity for improvement;

- West Moors Scout Hall LAP (44.7%), amenity grass is in poor condition.
- Alder Bed / Pennington Copse Amenity Greenspace (50%), improved management required
- Morelands Rise LAP (60%)

No schools have been quality assessed within West Moors. The schools have no formal dual use agreements, but should have a future role in providing for formal sport and recreation. School sites are generally of better quality, as they are secure and generally have some sort of on site management presence.

4.0 FINDINGS FROM SURVEY AND CONSULTATION

Citizen's Panel

32 people living in West Moors responded to the Citizen's Panel survey, and placed in the Central Settlements Sub Area (147 in total). This was the largest number of people responding from any one parish.

People living in the Central Settlements are less frequent (compared to the district as a whole) visitors to children's play areas, recreation footpaths, country parks, other local countryside and woodland and spaces to enjoy nature and wildlife. Otherwise their behaviour tends to reflect that of the district as a whole.

The types of open space respondents would like to see more of in the Central Settlements Sub Area are children's play areas and space for teenagers

The most important attributes of open space are that they should be easy to get to, clean, and safe and secure. The most important facilities to have in nearby open space areas are: trees, dog bins, seats and facilities for teenagers. Two thirds of respondents would like to use open spaces near them more often: more information, new facilities with more suitable facilities and more spare time (nothing that the district council can do about this!) would be important in encouraging this.

Local Areas of Open Space in West Moors

The areas used most are Moors Valley Country Park and West Moors playing field. Areas outside the district commonly mentioned were the New Forest around Ringwood and the Purbeck area, Hengistbury Head and the Mudeford area of Christchurch.

Other comments made highlighted:

- The provision of allotments in the West Moors or Ferndown area would be good (2 people mentioned)
- It is vitally important that all councils make superhuman efforts to preserve and improve our remaining spaces, particularly those which are habitats of rare or interesting flora/fauna. Building on any open space must be fought off at all costs.
- I think the open areas near West Moors are very good. I like the areas to be natural and am not in favour of greatly extending facilities. I prefer all weather tracks where I can run, bike and walk all year
- The spare field next to Fryers Field in West Moors intended for recreation is now fallow following routing of possible bypass road atrocity. Very sad!

Summary of Provision

There are two principal sites in the LNA, both to the north of the main road.

Fryers Playing Field: has a grassed bowling green and pavilion, tarmaced courts. Large well used grassed recreation ground with pavilion: 1 senior and 1 junior pitch

and 1 cricket pitch home to West Moors FC Saturday XI, West Moors Social Club FC (Sunday XI), 5 youth teams of West Moors youth and others like UK FH Cannon FC and West Moors CC. Also hall, skate park, play area and proposed open space around and 4 tennis courts and bowling green. This the most used open space in the parish and is maintained by the Parish Council, together with the open air courts at Oakhurst.

Wayfarers Sports Ground: is Grassed sports ground and pavilion with various uses: 2 senior football and 1 cricket pitch (4 wickets+); home to Forest Link FC 1st Sunday, Longfleet Youth FCU15,14,13,12,11, 2xminis and Wayfarers CC (1st XI).

There are also facilities at Dorset Fire & Rescue Service Sports Ground: Grassed recreation ground used for football (one pitch) and cricket with a pavilion, plus Tennis Court: Single tennis court with coloured tarmac surface

West Moors Parish Council

West Moors Parish Council stated that there was no need for additional or improved open space...no groups were identified as being poorly catered for. The Memorial Hall may have some spare capacity.


Schools

5.0 QUANTITY OF OPEN SPACE

5.1 Quantity standards for open space

Section 5 of the report outlines the quantity standards for open space within the District; a summary of these draft minimum standards is shown below:



5.2 Quantities of different types of open space

These standards have been applied at a local level to determine the provision of different types of open space across the adopted minimum standard, this is summarised in Table 4 which shows:

- the existing quantity of open space (existing provision);
- the required quantity of open space for the population of the area (required provision);
- the surplus or deficiency of open space (in m² and acres);
- Supply against the standard.

5.3 Key Points: Quantitative Provision of Open Space in West Moors

Fairly well provided for and standards met in most areas apart from active sports space and space for children and young people (and allotments). Although not a dedicated sports ground, Fryers Field Recreation Ground has pitches which are widely used for sports activities.

6.0 ISSUES ARISING IN WEST MOORS

- West Moors is an interesting area, being fairly modern and dominated by the West Moors Plantation.
- All three sports sites/recreation grounds are to the north of the trailway, leaving the southern section to west of the plantation outside the catchment for active sport and multi functional open space.
- There is a fairly good coverage of amenity open space, some areas of which in the south might provide the opportunity for additional play areas.

Current play provision is low in both quality and quantity; the priority is to improve provision for children and young people and to provide additional sites in the south.

 Across the District, provision of allotments is low and many LNAs have no allotment sites. As set out in Section 5, this Report recommends a new look at the burgeoning interest in allotment gardening, and how new sites can be brought into use to cater for growing demand.
