

## **Biodiversity Checklist**

- The below is intended as a guide to determine what ecological information will be required to support your planning application.
- The checklist will be reviewed by the validation team and your planning case officer. Where the checklist indicates that no surveys are required, further evidence such as photographs may be requested to enable this review. Incorrect information provided or a failure to provide necessary surveys is likely to cause delays in the validation/and or processing of your planning application.
- If the checklist indicates that surveys are required, but you believe this to be incorrect, please contact the Dorset Natural Environment Team at [biodiversityprotocol@dorsetcouncil.gov.uk](mailto:biodiversityprotocol@dorsetcouncil.gov.uk)
- If professional ecological advice has identified further surveys are required, these should always be undertaken before the application is submitted to the Planning Authority.
- In most cases, the results of the surveys indicated by the checklist should be compiled into an Ecological Impact Assessment (EclA), which is proportionate to the scale of the project.
- **Where a survey identifies an impact on biodiversity, certain supporting ecological information is required to be submitted with your application. We strongly recommend you follow the [Dorset Biodiversity Appraisal Protocol](#) and submit this to Dorset Council Natural Environment Team (DC NET) for review. The information required to be submitted is set out below, and on our webpages.**
