**Dorset Council (Footpath 107, Thorncombe at Gashay Farm)
Public Path Creation Order 2021**

This Order is made by Dorset Council ("the authority") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that, having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this order relates, and that it is expedient that the path should be created.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Dorset definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, the creation (as authorised by this Order) of a new right of way over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

Thorncombe Parish Council has been consulted as required by section 26(3) of the 1980 Act.

BY THIS ORDER:

1. There shall be at the end of 7 days from the date of confirmation of this Order a public footpath over the land at Gashay Farm, Thorncombe described in Part 1 of the Schedule to this Order and shown by a bold broken line on the map attached to this Order and thereupon the County of Dorset definitive map shall be modified by adding that path to it and the definitive statement shall be modified as described in Part 2 of the Schedule to this Order.

Description of land

Footpath 107, Thorncombe:

A – G From its junction with the proposed new route of Footpath 94, Thorncombe at point A (ST 37580061), north east along a grass/earth surfaced track to its junction with Gashay Lane (D10118) at point G (ST 37620066). Width: 2 metres.

Part 2

Modification of Definitive Statement

Footpath 107, Thorncombe:

From its junction with Footpath 94, Thorncombe, north east along a grass/earth surfaced track to its junction with Gashay Lane (D10118). Width: 2 metres.

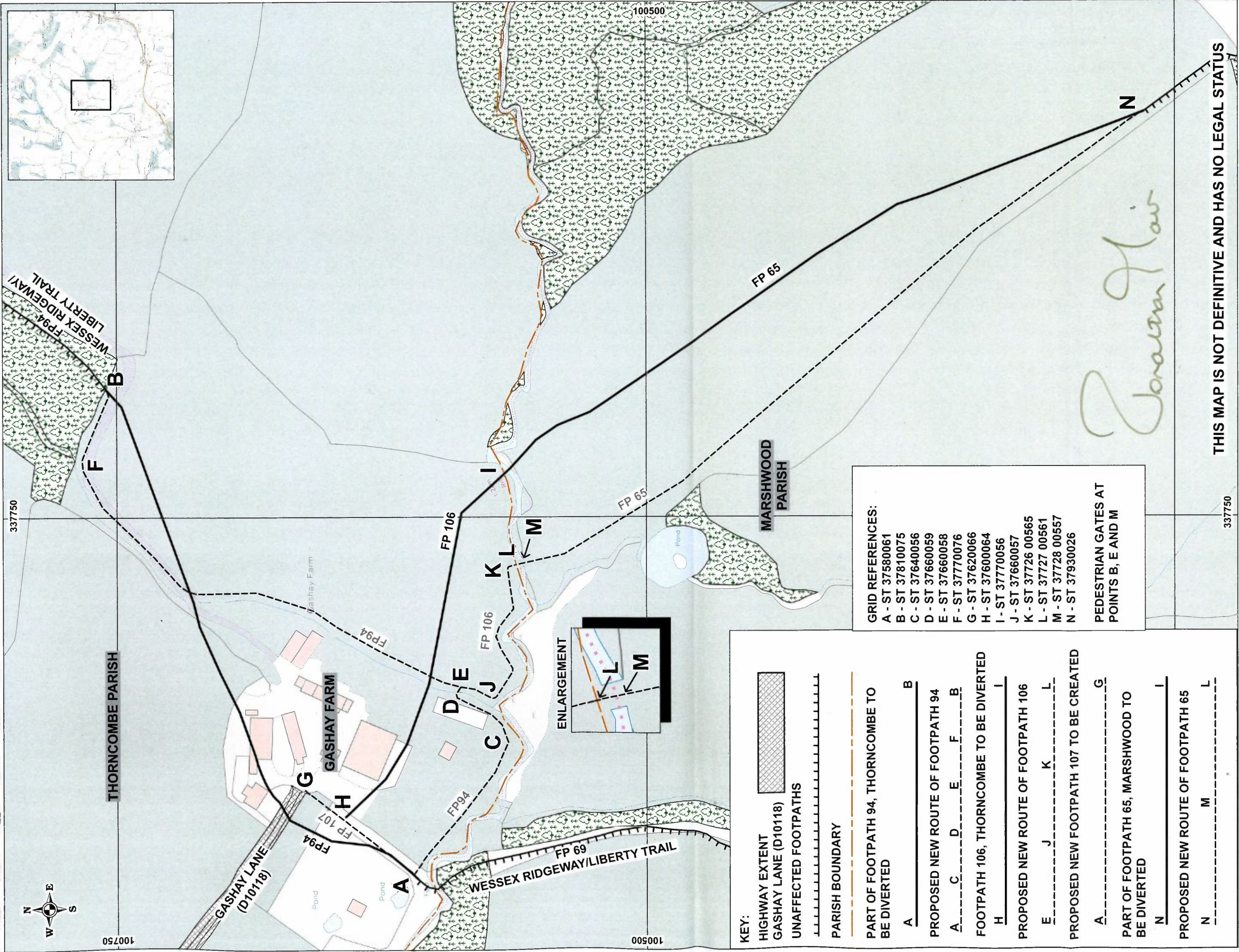
