**Dorset Council (Footpaths 92 and 96, Beaminster at Windy Ridge)  
Public Path Extinguishment Order 2021**

This Order is made by Dorset Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpaths described in paragraph 1 below are not needed for public use.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Dorset definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

Beaminster Town Council has been consulted as required by section 120(2) of the 1980 Act.

**BY THIS ORDER:**

1. The public rights of way over the land situate at Windy Ridge, Beaminster and shown by continuous bold lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be extinguished after 7 days from the date of confirmation of this Order and thereupon the County of Dorset definitive map shall be modified by deleting from it those public rights of way and the definitive statement shall be modified as described in Part 2 of the Schedule to this Order.
2. Notwithstanding this Order, where immediately before the date on which the paths are extinguished in pursuance of this Order, there is apparatus under, in, on, over, along or across the paths belonging to the statutory undertakers for the purpose of carrying out their undertaking then such undertakers shall continue to have the same rights in respect of their apparatus as they would have had if this Order had never been made.

## **SCHEDULE**

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

#### **Description of public rights of way extinguished**

##### **Footpath 92, Beaminster:**

A – C – D    The full width of the path from its junction with the current route of Footpath 69, north east of 14 Windy Ridge at point A (ST 47830164), west north west through the garage and front garden of the property to point C (ST 47820164), where it intersects with Footpath 96, Beaminster and Windy Ridge, then continuing west north west through the garden and property of 20 Windy Ridge and the garden of 18 Windy Ridge to point D (ST 47770165).

##### **Footpath 96, Beaminster:**

C – E        The full width of the path from its junction with Footpath 92, to the south east of 16 Windy Ridge at point C (ST 47820164), north north west through the garage and garden of the property to its junction with Footpath 70 at point E (ST 47810168).
