

## EXPEDITION NOTIFICATION OF DofE VENTURES (SCHOOLS) NOT IN WILD COUNTRY AREAS OR OVERSEAS

At least four weeks before your DofE venture

Complete your establishment equivalent \*process for authorisation and approval of offsite events by the designated **school** EVC or similar (EVC = Events Visit Coordinator)

Submit to your School EVC/Head for approval

The electronic form proceeds automatically to the DofE Mgr

\*EVOLVE: Ensure the Primary Purpose is "Duke of Edinburgh" and DofE Green Notification Form (May 2019 update) is attached as a supporting doc The electronic form/s proceed automatically to the DofE Mgr
