# 4. Please use the box below to give reasons for your support or objection, or to make your observation.

As I understand it, my objection to the plan ( strong and totally in agreement with the submissions of CPRE and the AONB), is sadly, no longer relevant here. However, I will state that I do object to the plan.

My objection at this stage, therefore, is to the notion of putting this ill-conceived and frankly outdated proposal to a referendum of all Blandford residents.

I, and my Letton neighbours, being Pimperne residents, will not have a say, and yet any perusal of the plans makes it clear that we will be those most affected, together with those Blandford residents at the north of the town.

The madness of building an estate of this size on the far side of the bypass has been already well documented by other objectors and I can only conclude that the Blandford Plus group concurs with the idea ( to misquote Austen) that a piece of land without a building on it must be in want of development!

Perhaps they don't see the queues of traffic along the bypass and up to the Hilltop roundabouts every day, as we do. Perhaps they have no idea of how interrupting an already busy road with yet another roundabout from the proposed housing estate (not to mention the new school, with all its associated traffic problems!) will affect the traffic in this area, but really, it takes little imagination or foresight to see the ensuing chaos.

However,I feel that the majority of Blandford residents will not be affected by this and a referendum on it which precludes the rights of those most affected, is flawed and deeply unfair. I also feel that few of the questions raised by the objectors have been really noted or addressed, particularly given the ongoing question over Norden, (which has been suggested as a site for the new primary school, )and the likely surplus in the required number of new homes in North Dorset, (see CPRE objection) should this development go ahead.

And an observation: Dorset Council lately declared a climate emergency. How does this development fulfil the Council's criteria on sustainability? Should we not be building on Brownfield sites as a first option- in line with current Government policy?

And surely the Council should require the developers to build eco friendly homes? Every house to have solar tiles or panels, electric car charging points, grey water recycling ,swift boxes...the possibilities are endless- and must be considered

This could be a flagship development or just another concrete jungle-although given the level of

traffic it is likely to generate, its green credentials are As I said at the beginning, these proposals, are out do What we need here is a proper public enquiry.	•
