This information statement is about the referendum to be held on the Piddle Valley Neighbourhood Plan

# About town and country planning

In England, planning applications are determined by local planning authorities such as West Dorset District Council. Planning decisions are made in accordance with the adopted development plan, unless material considerations indicate otherwise. A development plan sets out the planning policies for the development and use of land.

The <u>adopted Local Plan for West Dorset</u> is therefore the starting point for considering planning applications at the current time. The <u>national planning policy framework</u> must be taken into account in the preparation of local and neighbourhood plans, and is a material consideration in planning decisions.

Our <u>Local Development Scheme</u> contains information on development plan documents that are being prepared.

## About neighbourhood planning and the Piddle Valley Neighbourhood Plan

Neighbourhood planning aims to help local communities play a direct role in planning the areas in which they live and work. In parished areas, the Parish Council is responsible for preparing a neighbourhood plan. The plan can show how the community wants land to be used and developed in its area. If a plan is made following a successful referendum, it becomes part of the development plan for that area.

Piddle Valley Group Parish Council started preparing their neighbourhood plan in October 2012. After much research, and having listened to the various issues and suggestions made through various consultation events, a draft plan was produced for consultation in April 2015. The plan was then revised in response to the consultation and submitted to West Dorset District Council in March 2016 and subject to a further round of consultation ending in June 2016. Nigel McGurk was appointed as an Independent Examiner for the Piddle Valley Neighbourhood Plan, and in November 2016 he produced his <u>report</u> confirming that he was satisfied that the plan meets the basic conditions and recommended that it should, subject to some changes, proceed to referendum.

West Dorset District Council considered the <u>report</u> at Strategy Committee 8 February 2018 and issued its <u>decision statement</u> which was in agreement with the examiner's findings, and that the <u>plan as modified</u> should proceed to referendum.

# What the referendum is deciding

The question which will be asked in the referendum is:

"Do you want West Dorset District Council to use the neighbourhood plan for Piddle Valley to help it decide planning applications in the neighbourhood area?"

The referendum asks you to vote yes or no to this question.

### When and where the referendum will be held

The referendum will be held on Thursday 19 April 2018.

#### What is the area covered by the referendum?

The referendum area and the area covered by the neighbourhood plan are the Parishes of Piddlehinton, Piddletrenthide and Alton Pancras.

#### Who is entitled to vote?

You are entitled to vote in the referendum if you live in the referendum area, you are on the electoral register to vote in local council elections and you are 18 years of age or over on 19 April 2018.

You have to be registered to vote by Tuesday, 3 April 2018 to vote in the referendum. You can check if you are registered to vote by telephoning 01305 838299 during normal office hours.

#### How can people vote?

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.


You can vote in person at the polling station – The polling stations will be as follows EO – Piddlehinton Village Hall and EP1 and EP3 Piddletrenthide Memorial Hall. We will issue poll cards to voters at the beginning of March. The polling stations will be open from 7am to 10pm on 19 April 2018.

To vote by post or proxy in this referendum, you will need to have filled in an application form and sent it to the Electoral Registration Officer. Postal and proxy vote application forms are available online from the elections website <u>https://www.dorsetforyou.com/404855</u> or by contacting the district council.

Applications to vote by post must be received by 5pm on Wednesday, 4 April 2018. To vote by proxy, application forms should be received by 5pm on Wednesday 11 April 2018. However in certain circumstances emergency proxy vote applications can be received up until 5pm on the 19<sup>th</sup> of April 2018. Anyone can be your proxy as long as they are eligible to vote and are willing to vote on your behalf. You will have to tell them how you want to vote.

Ballot papers for people who vote by post will be posted from 10 April 2018, and will need to be returned by 10pm on the day of the poll, 19 April 2018.

# Referendum expenses

The referendum expenses limit that will apply in relation to the referendum is  $\pounds 2,362$  plus  $\pounds 0.059$  per registered elector (in February 2018 this was 1,038 people).
