In accordance with Paragraph 9 of Schedule 4B to the Town and Country Planning Act 1990 (as amended) the independent examiner, Mr Terry Kemmann-Lane JP DipTP FRTPI, has decided that a hearing is required for the purpose of receiving oral representations.

The hearing will take place at **The Badger's Sett, Sealy Suite, The Crown Hotel, West Street, Blandford Forum, Dorset, DT11 7AJ on 12 November 2019.** The hearing will commence at **9am**. It should be noted that any member of the public may attend the hearing, however, only specific persons may make oral representations, in accordance with Paragraph 9(3) of Schedule 4B to the Town and Country Planning Act 1990 (as amended).

Please note that the examiner intends to formally open the hearing at the venue detailed above before proceeding to a site visit as soon as the initial opening matters are dealt with. He envisages being back to continue the hearing at 2pm. In terms of the site visit the examiner requests that representatives of the Qualifying Body (Blandford Forum Town Council), Dorset Council, Cranborne Chase AONB Partnership, Pimperne Parish Council and Wyatt Homes attend.
