Information Statement

This information statement is about the referendum to be held on the Broadwindsor Neighbourhood Plan

About town and country planning

In England, planning applications are determined by local planning authorities such as Dorset Council. Planning decisions are made in accordance with the adopted development plan, unless material considerations indicate otherwise. A development plan sets out the planning policies for the development and use of land.

The <u>adopted Local Plan for West Dorset</u> is therefore the starting point for considering planning applications at the current time. The <u>national planning policy framework</u> must be taken into account in the preparation of local and neighbourhood plans, and is a material consideration in planning decisions.

Our <u>Local Development Scheme</u> contains information on development plan documents that are being prepared.

About neighbourhood planning and the Broadwindsor Neighbourhood Plan

Neighbourhood planning aims to help local communities play a direct role in planning the areas in which they live and work. In parished areas such as Broadwindsor, the Parish Council is responsible for preparing a neighbourhood plan. The plan can show how the community wants land to be used and developed in its area. If a plan is made following a successful referendum, it becomes part of the development plan for that area.

Broadwindsor Group Parish Council started preparing their plan neighbourhood plan in 2015. After much research, and having listened to the various issues and suggestions made through various consultation events, a draft plan was produced for consultation in February 2018. The plan was then revised in response to the consultation and submitted to West Dorset District Council in November 2018.

On 1 April 2019 the county's nine councils were replaced by two new organisations, Dorset Council and Bournemouth, Christchurch and Poole Council. Consequently West Dorset District Council as been replaced by Dorset Council as the Local Planning Authority for the Broadwindsor Neighbourhood area.

Mr Brian Dodd was appointed as an Independent Examiner for the Broadwindsor Neighbourhood Plan, and in April 2019 he produced his <u>report</u> confirming that he was satisfied that the plan meets the basic conditions and recommended that it should, subject to some changes, proceed to referendum.

Dorset Council considered the <u>report</u> at Cabinet 25 June 2019 and issued its <u>decision</u> which was in agreement with the examiner's findings, and that the <u>plan as modified</u> should proceed to referendum.

What the referendum is deciding

The question which will be asked in the referendum is:

"Do you want Dorset Council to use the neighbourhood plan for Broadwindsor to help it decide planning applications in the neighbourhood area?"

The referendum asks you to vote yes or no to this question.

When and where the referendum will be held

The referendum will be held on Thursday 8th August 2019.

What is the area covered by the referendum?

The referendum area and the area covered by the neighbourhood plan are the parishes of as Broadwindsor, Burstock and Seaborough.

Who is entitled to vote?

You are entitled to vote in the referendum if you live in the referendum area, you are on the electoral register to vote in local council elections and you are 18 years of age or over on 8 August 2019.

You have to be registered to vote by Tuesday, 23 July 2019 to vote in the referendum. You can check if you are registered to vote by telephoning 01305 838299 during normal office hours.

How can people vote?

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.


You can vote in person at the polling stations – which are at Drimpton Village Hall, Blackdown Village Hall and Comrades Hall, Broadwindsor. We will issue poll cards to voters on 12 July 2019. The polling station will be open from 7am to 10pm on 8 August 2019.

To vote by post or proxy in this referendum, you will need to have filled in an application form and sent it to the Electoral Registration Officer. Postal and proxy vote application forms are available online from the elections website https://www.dorsetcouncil.gov.uk/councillors-committees-elections/elections-and-voting/ways-you-can-vote.aspx or by contacting the district council.

Applications to vote by post must be received by no later than 5pm on Wednesday, 24 July 2019. To vote by proxy, application forms should be received by no later than 5pm on Wednesday, 31 July 2019. However in certain circumstances emergency proxy vote applications can be received up until 5pm on 8th August 2019. Anyone can be your proxy as long as they are eligible to vote and are willing to vote on your behalf. You will have to tell them how you want to vote.

Ballot papers for people who vote by post will be posted from 24 July 2019, and will need to be returned by 10pm on the day of the poll.
