The modifications are set out in the Schedule of Modifications and in the 'Modified Mineral Sites Plan'. They include main modifications necessary for the Mineral Sites Plan to be capable of being found 'sound' and additional modifications, which do not impact on whether the Plan is 'sound' or not. Main modifications are written in underlined red text and have the prefix 'MM' Additional modifications are written in underlined red italics and have the prefix 'AM'.
- If your representation does not relate to a modification it will not be valid.
- Please make it clear which modification your representation relates to reference numbers can be found in the Schedule of Modifications and are written in brackets in the Modified Plan.
- A separate representation form should be provided for each modification commented on.





5. The map shows that house 1 would be right on the border of AS25 and house 2 only a short distance from AS25 border.

6. Both these houses would be closer to AS25 than any house on Station Road with the incorporation of the new border shown along Station Road on the map on the preceding page.

7. The map also shows how close the Moreton Station caravan park will be to the southern border of AS25. The caravan park will be much closer to AS25 than any sensitive receptor to the north of AS26 and AS19 including the Sculptures By The Lakes.

8. The Moreton Parish Council proposal is for the southern boundary to be moved back to the dotted line which is an extension of the existing boundary as shown.

9. This would correspond to the statement in MM61.1 on page 58:

1. To offset impacts from noise, vibration and dust on the Moreton Conservation Area in general and East Cottage and Lilac Cottage/Santa Maria in particular, the north-eastern boundary of the proposed site will be moved back (southwards) to the next field boundary to the south.....

10. The proposal for the southern boundary explained above would ... offset impacts from noise, vibration and dust ... on the two houses shown and also on the caravan park and houses in Moreton Station settlement.

11. Because the proposed new southern bourndary is merely an extension of an existing part of the southern boundary it should make the extraction and restoration process easier by virture of the equipment not having to divert to cover a relatively short length of the quarry.

12. In terms of the overall quantity of aggregate which may be extracted from AS25 (3.1 million tonnes), the reduction due to the non-extraction of the proposed area will hardly register.
