Definitive Map and Statement Modification Order 2022

This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

1. For the purposes of this Order the relevant date is 15 March 2022.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (A Footpath from Holton Heath Trading Park to Rockley Jetty, Wareham St Martin) Definitive Map and Statement Modification Order 2022".

Part I

Modification of definitive map Description of path to be added

A – B – C From its junction with Holton Road at the roundabout at Holton Heath Trading
– C1 – D Park at point A (SY 95259092), generally south east along a tarmac surfaced
– E – F – estate road and footway, passing to the east of Holton Heath Trading Park to
G point B (SY 95459082) then continuing east north east along a gravel then
earth surfaced path, running parallel with the railway line to point C (SY
95819089) and east north east, along a grass/earth surface track, passing
through woodland (via point C1 (SY 95929094)) to point D (SY 96279097).
Continuing south east, along a grass/earth surface track, crossing the railway
line at point E (SY 96359093), turning east, running parallel with the railway
line to point F (SY 96889098) then south east to a land spit in Poole Harbour
(known as Rockley Jetty) at point G (SY 97009090). Width: 7 metres between
point A (SY 95259092) and point B (SY 95459082), narrowing to 5 metres
between point B (SY 95459082) and point G (SY 97009090).

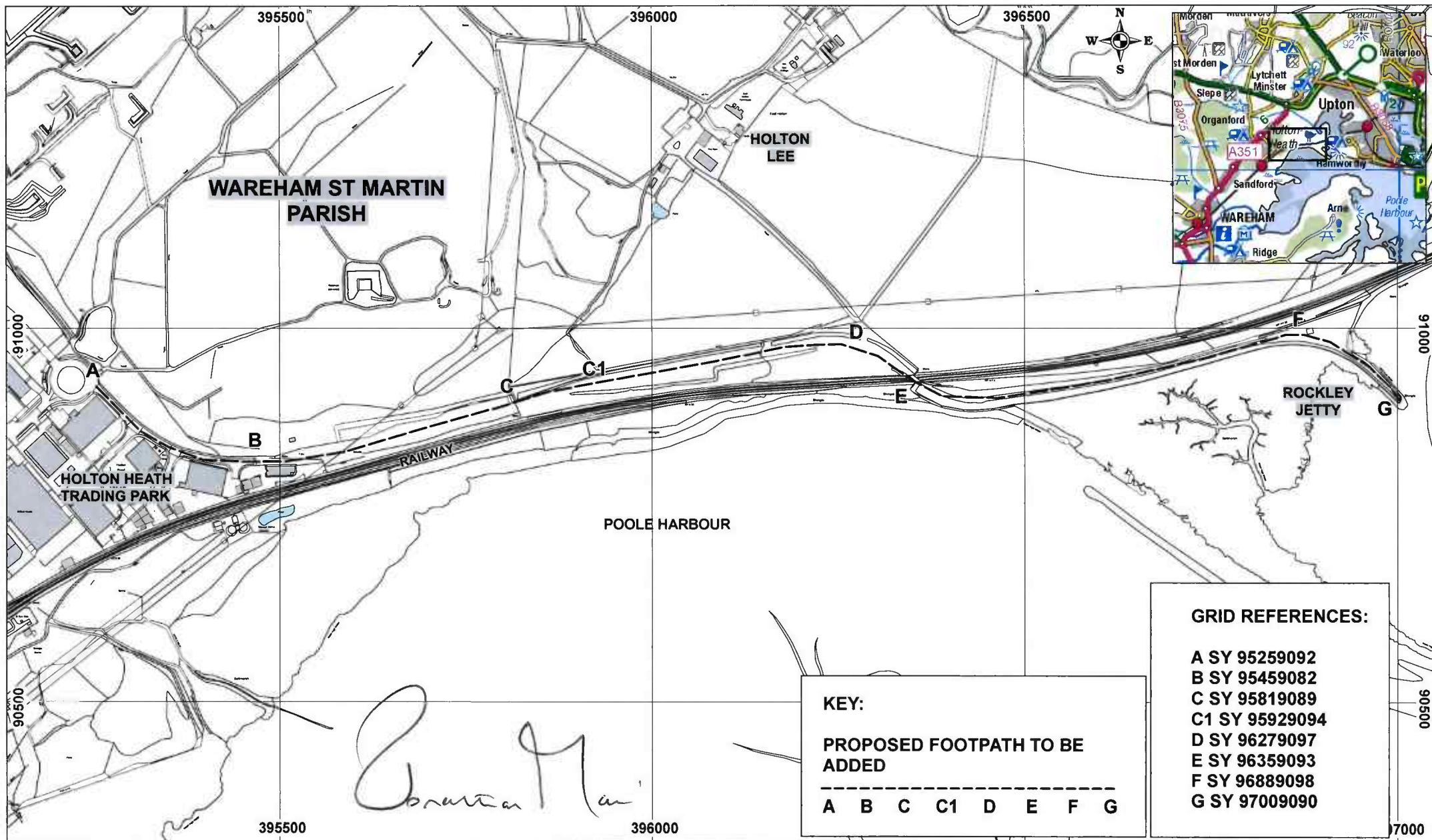

Footpath 30, Wareham St Martin

From its junction with Holton Road at the roundabout at Holton Heath Trading Park, generally south east along a tarmac surfaced estate road and footway, passing to the east of Holton Heath Trading Park to SY 95459082 then continuing east north east along a gravel then earth surfaced path, running parallel with the railway line to SY 95819089 and east north east, along a grass/earth surface track, passing through woodland (via SY 95929094) to SY 96279097. Continuing south east, along a grass/earth surface track, crossing the railway line at SY 96359093, turning east, running parallel with the railway line to SY 96889098 then south east to a land spit in Poole Harbour (known as Rockley Jetty). Width: 7 metres between SY 95259092 and SY 95459082, narrowing to 5 metres between SY 95459082 and SY 97009090.
