**Dorset Council (Bridleways and a Footpath to be added in
Stony Down Plantation, Corfe Mullen)
Definitive Map and Statement Modification Order 2023**

This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

1. For the purposes of this Order the relevant date is 25 May 2023.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (Bridleways and a Footpath to be added in Stony Down Plantation, Corfe Mullen) Definitive Map and Statement Modification Order 2023".

Part I

Modification of definitive map Description of ways/path to be added

Bridleway 48, Corfe Mullen:

- A – P – From its junction with Bridleway 22 at point A (SY 96909604), north north
O west along an earth/gravel/grass surfaced track, to its junction with the proposed new Bridleway 49 at point P (SY 96679654) then continuing north north west, then north east along an earth/grass surfaced path to its junction with the proposed new Bridleway 50 and Bridleway 51 at point O (SY 96689660). The width varies: 3-4 metres between point A (SY 96909604) and point P (SY 96679654), narrowing to 2-3 metres between point P (SY 96679654) and point O (SY 96689660).

Bridleway 49, Corfe Mullen:

- P – N From its junction with the proposed new Bridleway 48 at point P (SY 96679654), east north east along a grass surfaced path to its junction with the proposed new Bridleway 51 at point N (SY 96889664). Width: 3 metres.

Bridleway 50, Corfe Mullen:

- O – M – From its junction with the proposed new Bridleway 48 and Bridleway 51 at
G point O (SY 96689660), generally north along an earth surfaced track to its junction with the proposed new Bridleway 52 at point M (SY 96649672) and continuing north and then east to its junction with Bridleway 22 and the proposed new Bridleway 58 and Bridleway 60 at point G (SY 96799696). The width varies: 50 centimetres -1.5 metres between point O (SY 96689660) and point M (SY 96649672), widening to 1-2 metres between point M (SY 96649672) and point G (SY 96799696).

Bridleway 51, Corfe Mullen:

- O – N – From its junction with the proposed new Bridleway 48 and Bridleway 50 at
E point O (SY 96689660), east along an earth surfaced path to its junction with the proposed new Bridleway 49 at point N (SY 96889664) and continuing east along a stone surfaced track to its junction with Bridleway 22 and the proposed new Bridleway 52, Bridleway 56, and Bridleway 57 at point E (SY 96909664). Width: 3 metres.

Bridleway 52, Corfe Mullen:

- M – E From its junction with the proposed new Bridleway 50 at point M (SY 96649672), east south east along a grass then sand surfaced path to its junction with Bridleway 22 and the proposed new Bridleway 51, Bridleway 56 and Bridleway 57 at point E (SY 96909664). The width varies: 50 centimetres at point M (SY 96649672), widening to 3 metres at point E (SY 96909664).

Bridleway 53, Corfe Mullen:

- B – T – From its junction with Bridleway 22 at point B (SY 96939614), north east
Q – R along a grass/earth surfaced track to its junction with the proposed new
Bridleway 54 at point T (SY 97149624) and continuing along a crushed stone
surfaced track to point Q (SY 97159634) then turning west to its junction with
proposed new Bridleway 55 at point R (SY 97039636).
The width varies: 3-5 metres between point T (SY 97149624) and point Q (SY
97159634), narrowing to 3-4 metres between point Q (SY 97159634) and
point R (SY 97039636).

Bridleway 54, Corfe Mullen:

- S – T From its junction with the proposed new Bridleway 55 at point S (SY
97029632), south east along a stone surfaced track to its junction with the
proposed new Bridleway 53 at point T (SY 97149624).
The width varies between 3-5 metres.

Bridleway 55, Corfe Mullen:

- C – S – From its junction with Bridleway 22 at point C (SY 96949618), north east
R – D along a stone surfaced track to its junction with the proposed new Bridleway
54 at point S (SY 97029632), then north to its junction with the proposed new
Bridleway 53 at point R (SY 97039636) and north west to its junction with
Bridleway 22 and the proposed new Bridleway 56 at point D (SY 96949643).
The width varies between 3-5 metres.

Bridleway 56, Corfe Mullen:

- D – E From its junction with Bridleway 22 and the proposed new Bridleway 55 at
point D (SY 96949643), north west, then north along a tarmac/stone surfaced
track, to its junction with Bridleway 22 and the proposed new Bridleway 51,
Bridleway 52 and Bridleway 57 at point E (SY 96909664).
The width varies between 4-5 metres.

Bridleway 57, Corfe Mullen:

- E – K From its junction with Bridleway 22 and the proposed new Bridleway 51,
Bridleway 52 and Bridleway 56 at point E (SY 96909664), north east along a
grass surfaced track to its junction with the proposed new Bridleway 59 and
Footpath 61 at point K (SY 97129675).
The width varies between 3-4 metres.

Bridleway 58, Corfe Mullen:

- F – G From its junction with Bridleway 22 at point F (SY 96909675), north east then
turning west, along a stone surfaced track to rejoin Bridleway 22 at its junction
with the proposed new Bridleway 50 and Bridleway 60 at point G (SY
96799696).
The width varies between 3-4 metres.

Bridleway 59, Corfe Mullen:

- J – K From its junction with Bridleway 22 at point J (SY 97039712) south to its
junction with the proposed new Bridleway 57 and Footpath 61 at point K (SY
97129675). Width: 3 metres.

Bridleway 60, Corfe Mullen:

- I – G From its junction with Bridleway 22 at point I (SY 97109723), south west along an earth surfaced track to rejoin Bridleway 22 and its junction with the proposed new Bridleway 50 and Bridleway 58 at point G (SY 96799696). The width varies between 50 centimetres and 2 metres.

Footpath 61, Corfe Mullen:

- K – L – From its junction with the proposed new Bridleway 57 and Bridleway 59 at
L1 – H point K (SY 97129675), south (via point L (SY 97129673)) to point L1 (SY 97129664) then turning east and generally north to its junction with Bridleway 22 at point H (SY 97119721). The width varies between 50 centimetres and 2 metres.

Bridleway 48, Corfe Mullen:

From: SY 96909604 To: SY 96689660

From its junction with Bridleway 22, north north west along an earth/gravel/grass surfaced track, to its junction with Bridleway 49 at SY 96679654 then continuing north north west, then north east along an earth/grass surfaced path to its junction with Bridleway 50 and Bridleway 51. The width varies: 3-4 metres between SY 96909604 and SY 96679654, narrowing to 2-3 metres between SY 96679654 and SY 96689660.

Bridleway 49, Corfe Mullen:

Add:

From: SY 96679654 To: SY 96889664

From its junction with Bridleway 48, east north east along a grass surfaced path to its junction with Bridleway 51. Width: 3 metres.

Bridleway 50, Corfe Mullen:

Add:

From: SY 96689660 To: SY 96799696

From its junction with Bridleway 48 and Bridleway 51, generally north along an earth surfaced track to its junction with Bridleway 52 at SY 96649672 and continuing north and then east to its junction with Bridleway 22, Bridleway 58 and Bridleway 60. The width varies: 50 centimetres -1.5 metres between SY 96689660 and SY 96649672, widening to 1-2 metres between SY 96649672 and SY 96799696.

Bridleway 51, Corfe Mullen:

Add:

From: SY 96689660 To: SY 96909664

From its junction with Bridleway 48 and Bridleway 50, east along an earth surfaced path to its junction with Bridleway 49 at SY 96889664 and continuing east along a stone surfaced track to its junction with Bridleway 22, Bridleway 52, Bridleway 56, and Bridleway 57. Width: 3 metres.

Bridleway 52, Corfe Mullen:

Add:

From: SY 96649672 To: SY 96909664

From its junction with Bridleway 50, east south east along a grass then sand surfaced path to its junction with Bridleway 22, Bridleway 51, Bridleway 56 and Bridleway 57. The width varies: 50 centimetres at SY 96649672, widening to 3 metres at SY 96909664.

Bridleway 53, Corfe Mullen:

Add:

From: SY 96939614 To: SY 97039636

From its junction with Bridleway 22, north east along a grass/earth surfaced track to its junction with Bridleway 54 at SY 97149624 and continuing along a crushed stone surfaced track to SY 97159634 then turning west to its junction with Bridleway 55. The width varies: 3-5 metres between SY 97149624 and SY 97159634, narrowing to 3-4 metres between SY 97159634 and SY 97039636.

Bridleway 54, Corfe Mullen:

Add:

From: SY 97029632 To: SY 97149624

From its junction with Bridleway 55, south east along a stone surfaced track to its junction with Bridleway 53. The width varies between 3-5 metres.

Bridleway 55, Corfe Mullen:

Add:

From: SY 96949618 To: SY 96949643

From its junction with Bridleway 22, north east along a stone surfaced track to its junction with Bridleway 54 at SY 97029632, then north to its junction with Bridleway 53 at SY 97039636 and north west to its junction with Bridleway 22 and Bridleway 56. The width varies between 3-5 metres.

Bridleway 56, Corfe Mullen:

Add:

From: SY 96949643 To: SY 96909664

From its junction with Bridleway 22 and Bridleway 55, north west, then north along a tarmac/stone surfaced track, to its junction with Bridleway 22, Bridleway 51, Bridleway 52 and Bridleway 57. The width varies between 4-5 metres.

Bridleway 57, Corfe Mullen:

Add:

From: SY 96909664 To: SY 97129675

From its junction with Bridleway 22, Bridleway 51, Bridleway 52 and Bridleway 56, north east along a grass surfaced track to its junction with Bridleway 59 and Footpath 61. The width varies between 3-4 metres.

Bridleway 58, Corfe Mullen:

Add:

From: SY 96909675 To: SY 96799696

From its junction with Bridleway 22, north east then turning west, along a stone surfaced track to rejoin Bridleway 22 at its junction with Bridleway 50 and Bridleway 60. The width varies between 3-4 metres.

Bridleway 59, Corfe Mullen:

Add:

From: SY 97039712 To: SY 97129675

From its junction with Bridleway 22 south to its junction with Bridleway 57 and Footpath 61.
Width: 3 metres.

Bridleway 60, Corfe Mullen:

Add:

From: SY 97109723 To: SY 96799696

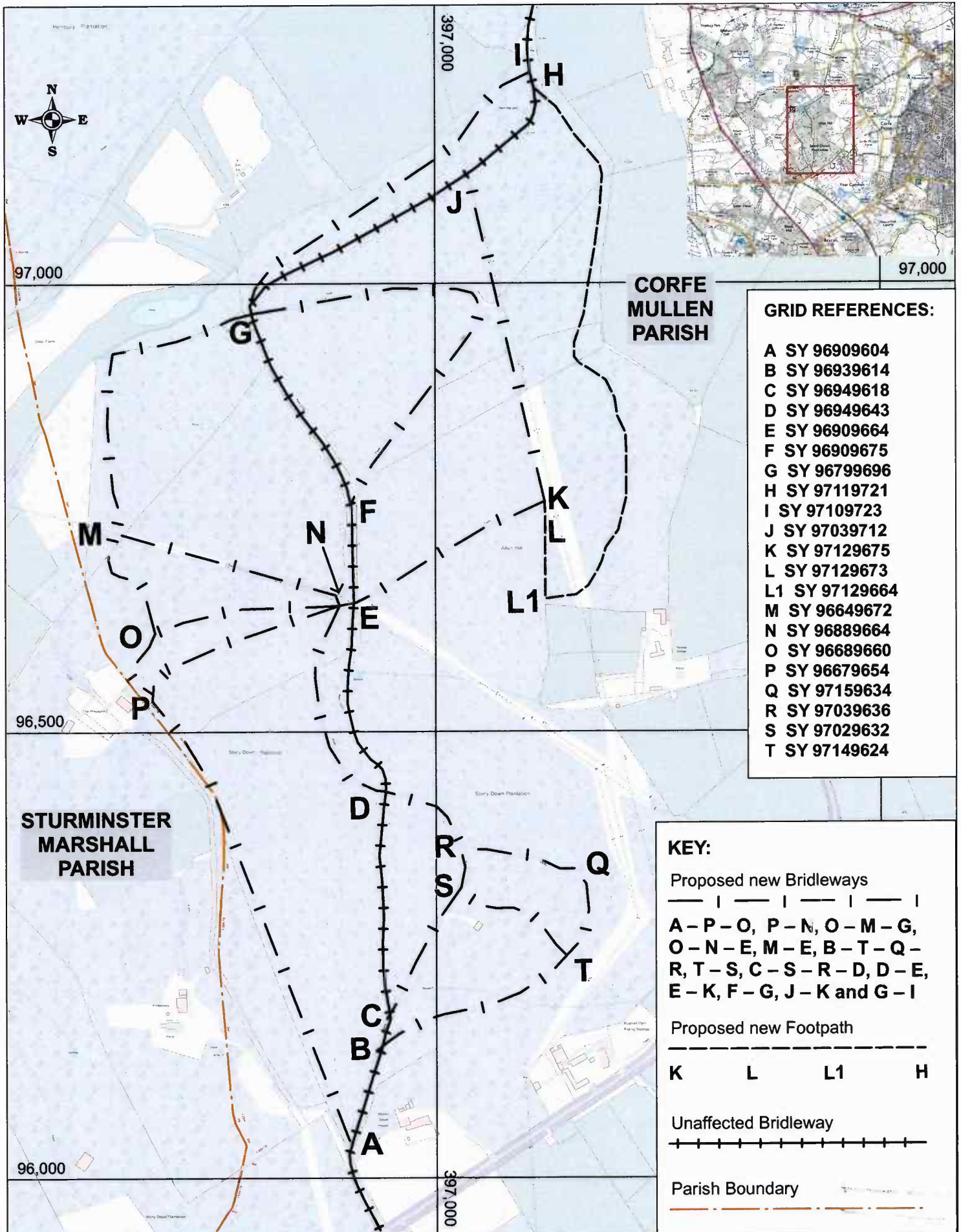
From its junction with Bridleway 22, south west along an earth surfaced track to rejoin
Bridleway 22 and its junction with Bridleway 50 and Bridleway 58. The width varies between
50 centimetres and 2 metres.

Footpath 61, Corfe Mullen:

Add:

From: SY 97129675 To: SY 97119721

From its junction with Bridleway 57 and Bridleway 59, south (via SY 97129673) to SY
97129664 then turning east and generally north to its junction with Bridleway 22. The width
varies between 50 centimetres and 2 metres.
