

**THE DORSET COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATION)
(AMENDMENT NO. 2) ORDER 2024**

Dorset Council, having consulted with the chief officer of Dorset Police in exercise of the powers conferred by the Road Traffic Regulation Act 1984 as amended, the Local Government Act 1985 and the Traffic Management Act 2004 and in compliance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and all other powers so enabling hereby makes the following order:

Part 1: Implementation and citation

1. This Order has now been made and shall come into operation on 19th February 2024 and may be cited as 'The Dorset Council (Off-Street Parking Places) (Consolidation) (Amendment No. 2) Order 2024'.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

Part 2: Additions, Revocations and modifications

1. 'The Dorset Council (Off-Street Parking Places) (Consolidation) Order 2022' is hereby amended insofar as it relates to the following changes in SCHEDULE 1 of that Order;
 - a) The removal of motorhome parking from the following car parks;
 - Royal Yard, Weymouth
 - Park Lane, Wimborne
 - b) Change from 'multiuse area' to 'coaches only' in Bell Street, Shaftesbury car park.
 - c) The provision of parking for motorhomes up to 8 metres has been added to Lodmoor, Weymouth car park.
 - d) The removal of the 7-Day coach ticket in Bell Street, Shaftesbury car park.
 - e) The provision of parking for School Buses has been added to Westfield Close Car Park, Wimborne.

f) The addition of the following car parks:

2. 'The Dorset Council (Off-Street Parking Places) (Consolidation) Order 2022' is hereby amended to include the following addition in PART A DEFINITIONS of that Order;

a) "**School Bus**" means a vehicle that is adapted or constructed to carry more than 8 passengers and is used in conveying children to and from school during the school term

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
