A year planner showing availability for a public inquiry is not enclosed but can be provided if the Inspectorate considers that a public inquiry is required. The Council consider that the Order should be considered by written representation.

The land affected by the Order is unregistered and dispensation was received from the Secretary of State (Document Ref 14). Owners of land adjoining the Order Route, Mr and Mrs O'Hara of Deansbrook Farm, claim to own part of the Order Route but have not submitted any supporting evidence to validate this assertion.

The application was originally made by the Friends of Dorset Rights of Way (FoDRoW), Mr J Steward, Dairy Barn, Coombe Keynes, Wareham, Dorset BH20 5PS. The Trail Riders Fellowship have now assumed the position of applicant and are represented by:
