WILDLIFE AND COUNTRYSIDE ACT 1981 – SECTION 53 Dorset Council (A Byway Open to All Traffic, Batcombe and Leigh at Bailey Drove) Definitive Map and Statement Modification Order 2020

I am directed by the Secretary of State for the Environment, Food and Rural Affairs to refer to your e-mail dated 23 October 2020 requesting dispensation concerning the service of notice on owners and occupiers in respect of the above.

It is noted that, despite your extensive enquiries, you have not been able to ascertain the ownership of the land in question.
