

Temporary Parking Suspension of A356 Dorchester Road, Maiden Newton

DORSET COUNCIL has made an Order under Section 14 [1] of the Road Traffic Regulations Act 1984, as amended. All vehicles will be prohibited from parking along A356 DORCHESTER ROAD, MAIDEN NEWTON for 75 metres at either side of its junction with Hill View (150metres total). The Order is needed in order to comply with health and safety regulations, which require the provision of safe working areas and to minimise the likelihood of danger to highway users. It will come into operation on 5 April 2021 between 0930 and 1530 and will remain in force for 18 months, however it is anticipated that the works will be completed by 16 April 2021.

This Order will enable Purlieu Property Services, safe access to accommodate temporary traffic signals to allow the build of a flint wall alongside the A356.

DORSET COUNCIL intend, not less than seven days from the date of this notice to make an Order under Section 14. [1] of the Road Traffic Regulations Act 1984, as

- to impose a clearway to prevent waiting or parking on the carriageway of the C8, between a point approximately 25 metres south of the vehicle access to Marley Wood House, Winfrith Newburgh, and the junction of Church Road and West Road, West Lulworth, a distance of approximately 2.75 kilometres, and
