I have been a resident of Fleet for fourteen years. I would like to give my opinion on the proposed application to build a dwelling on the land at Fleet Common adjoining Stone Cottage.

The neighbourhood plan was put forward before the now ongoing development of Gaolan woods on Fleet road. This is an area which will house many park homes which will be available to buy. Local residents are not in favour of this as the ancient woodland has been taken down and the beautiful area destroyed. However as I understand it this will continue to be developed despite being in an area of outstanding natural beauty and the objections by local residents. This development together with any further building in the area will only increase the noise and traffic along Fleet road and reduce the tranquillity of this beautiful hamlet.

In light of this and the huge new housing development in Chickerell I feel any further affordable housing development in Fleet is unnecessary and not required. There are no pavements/ street lighting/shops etc. I am concerned that this may be the thin end of the wedge for further development and may actually cause residents to move out of the area rather than stay.
