TOWN & COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1977 (AS AMENDED)

WHEREAS the Purbeck District Council ("the Council") being the local planning authority is of the opinion that development of the description set out in the Schedule hereto should not be carried out on the land situated at Bladen Valley Briantspuddle in the Parish of Affpuddle in the County of Dorset shown hatched black and edged red on the plan annexed hereto unless permission therefor is granted on application made under the Town and Country Planning General Development Order 1977 as amended (hereinafter called "the Order")

AND WHEREAS the Council is further of the opinion that development of the said description would constitute a threat to the amenities of its area and that the provisions of paragraph 3(b) of article 4 of the Order should apply to this direction

NOW THEREFORE the Council in pursuance of the powers conferred upon it by the said article 4 HEREBY DIRECTS that the permission granted by article 3 of the Order shall not apply to development on the said land of the description set out in the Schedule hereto

THIS DIRECTION is made pursuant to paragraph 3(b) of the said article 4 and shall remain in force until 1st March 1988 (being six months from the date of this direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date

SCHEDULE

The erection or construction of gates, fences, walls or other means of enclosure and the maintenance, improvement or other alteration of any gates, fences, walls or other means of enclosure being development referred to in article 3 of and paragraph 1 of Class II of Schedule 1 to the Order and not being development comprised within any other Class

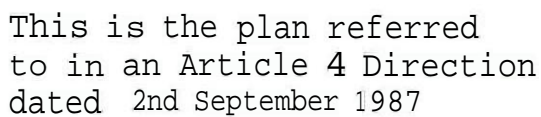
