TOWN AND COUNTRY PLANNING GENERAL

DEVELOPMENT ORDERS 1977 - 1983

WHEREAS:- Wimborne District Council being the Local Planning Authority within the meaning of Article 4 of the Town and Country Planning General Development Orders 1977 <sup>-1983</sup> are of the opinion that development of the descriptions set out in the Schedule hereto should not be carried out on land at Wedge Hill Farm Woodlands Dorset being the land shown edged red on the plan annexed hereto unless permission therefor is granted on an application made under the Town and Country Planning General Development Orders 1977 - 1983

AND WHEREAS the Council on the 1st day of December 1983 made a Direction under Article 4 (3)(b) of the Town and Country Planning General Development Orders 1977 <sup>-1983</sup> affecting the said land at Wedge Hill Farm Woodlands which said Direction will expire on the 1st day of June 1984 unless before that date it is confirmed by the Secretary of State for the Environment

NOW THEREFORE the Council in pursuance of Article 4(7) of the Town and Country Planning General Development Orders 1977-1983 hereby cancels the aforementioned Direction made on the 1st day of December 1983 and in substitution therefor the Council in pursuance of the powers conferred on them by the said Article 4 HEREBY DIRECT that the permission granted by Article 3 of the Town and Country Planning General Development Orders 1977 <sup>-1983</sup> shall not apply to the development on the said land of the descriptions set out in the Schedule hereto

This Direction is made in pursuance of Paragraph 1 of the said Article \_\_\_\_\_


SCHEDULE

The use of land (other than a building <sup>r</sup> on the curtilage of a building) on not more than 28 days <sup>in total</sup> in any calendar year for the purpose of bicycle moto-cross racing and clay-pigeon shooting meetings and on not more than 14 days <sup>in total</sup> in any calendar year for motor-cycle racing, and the erection or placing of moveable structures on the land for the purpose of those uses; being development comprised within Class IV specified in Schedule 1 to the Town and Country Planning General <sup>-1983</sup> Development Orders 1977 and not being development comprised within any other class \_\_\_\_\_
