WHEREAS the Mayor Aldermen and Burgesses of the Borough of Weymouth and Melcombe Regis, acting by the Council of the said Borough (hereinafter called "the Corporation") under powers delegated to them by the County Council of the Administrative County of Dorset (hereinafter called "the County Council") (being the Local Planning Authority for the said Borough), are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be undertaken on the land at the junction of Dorchester Road and Nottington Lane, Weymouth shown coloured pink on the plan annexed hereto being enclosure number 6763 on O.S. Sheet Number SY 6682 (1956 Edition) unless permission therefor is granted on application made under the Town and Country Planning Act 1971 and the Town and Country Planning General Development Order").

NOW THEREFORE the Corporation, in pursuance of the powers conferred upon the County Council by Article 4 of the General Development Order and delegated to the Corporation by the County Council, DIRECT that the permission granted by Article 3 of the General Development Order shall not apply to development on the said land of the description set out in the Schedule hereto.

SCHEDULE

The use of the said land (other than a building or the curtilage of a building) for the purpose of a travelling circus or travelling fair on not more than Twenty eight days in total in any calendar year, and the erection or placing of moveable structures on the land for the purposes of that use, being development comprised within Class is 2 referred to in Schedule 1 to the General Development Order and not being development comprised within any other class.
